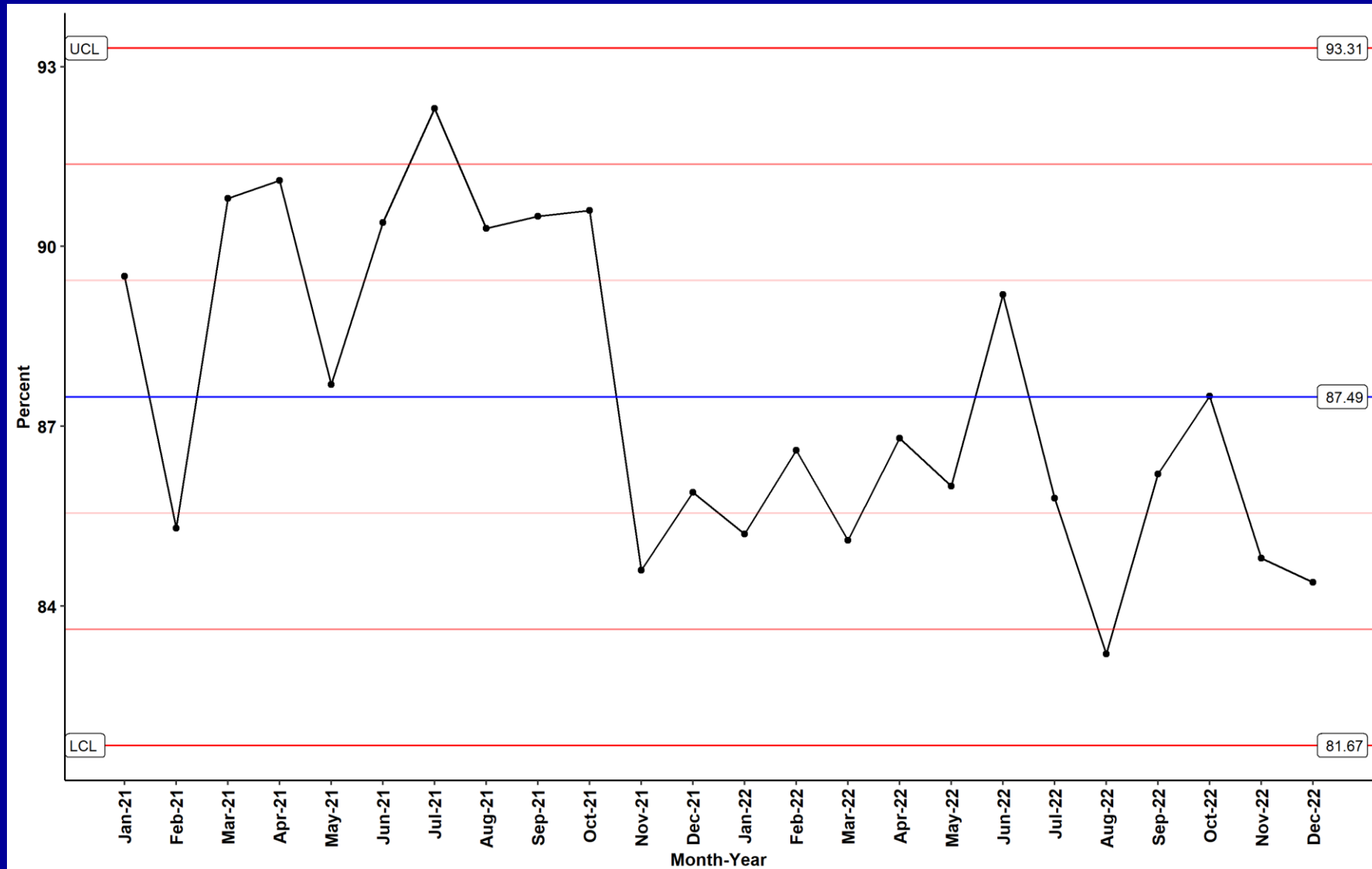
TRA-1 : Scene time for trauma patients



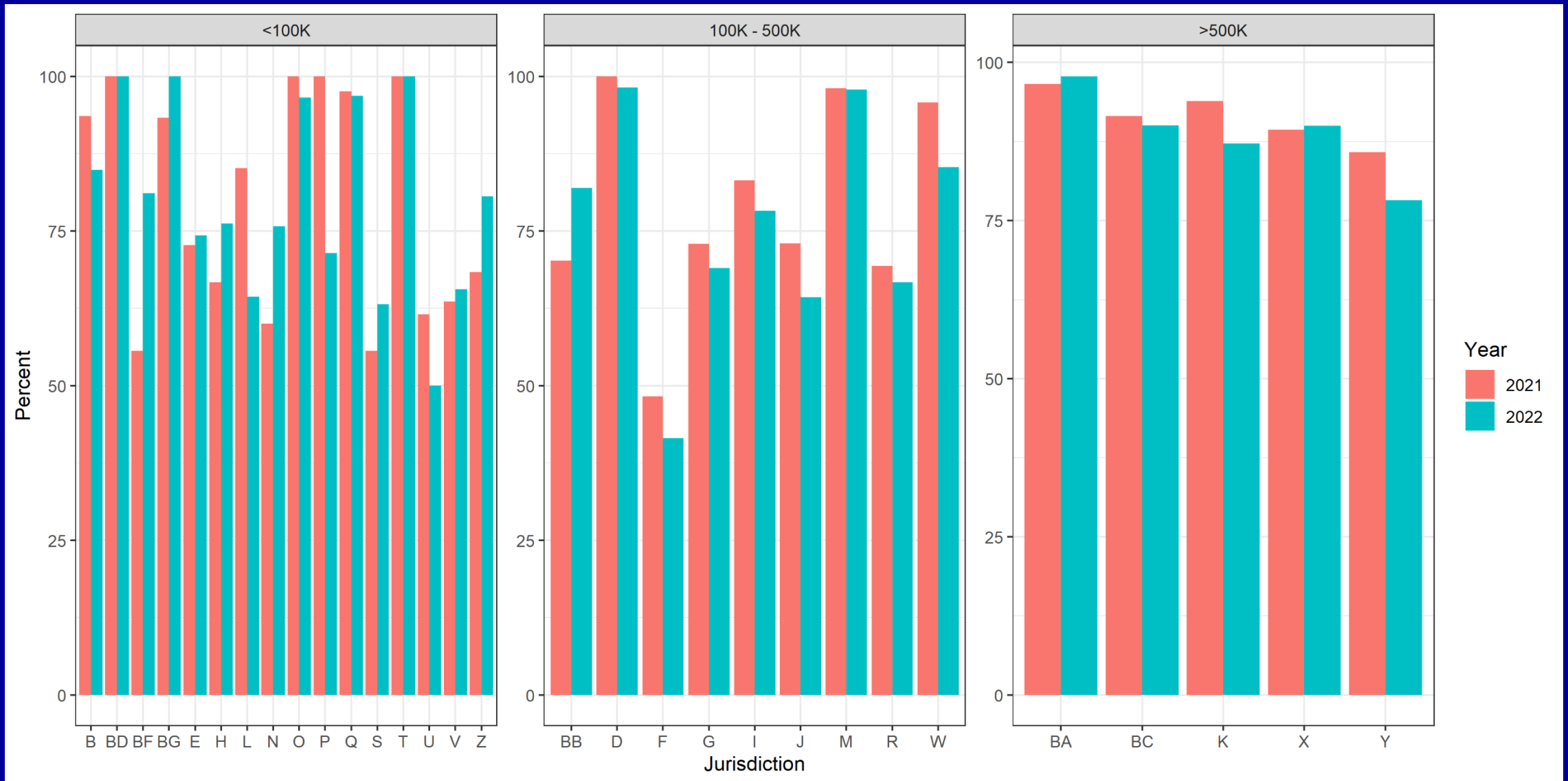

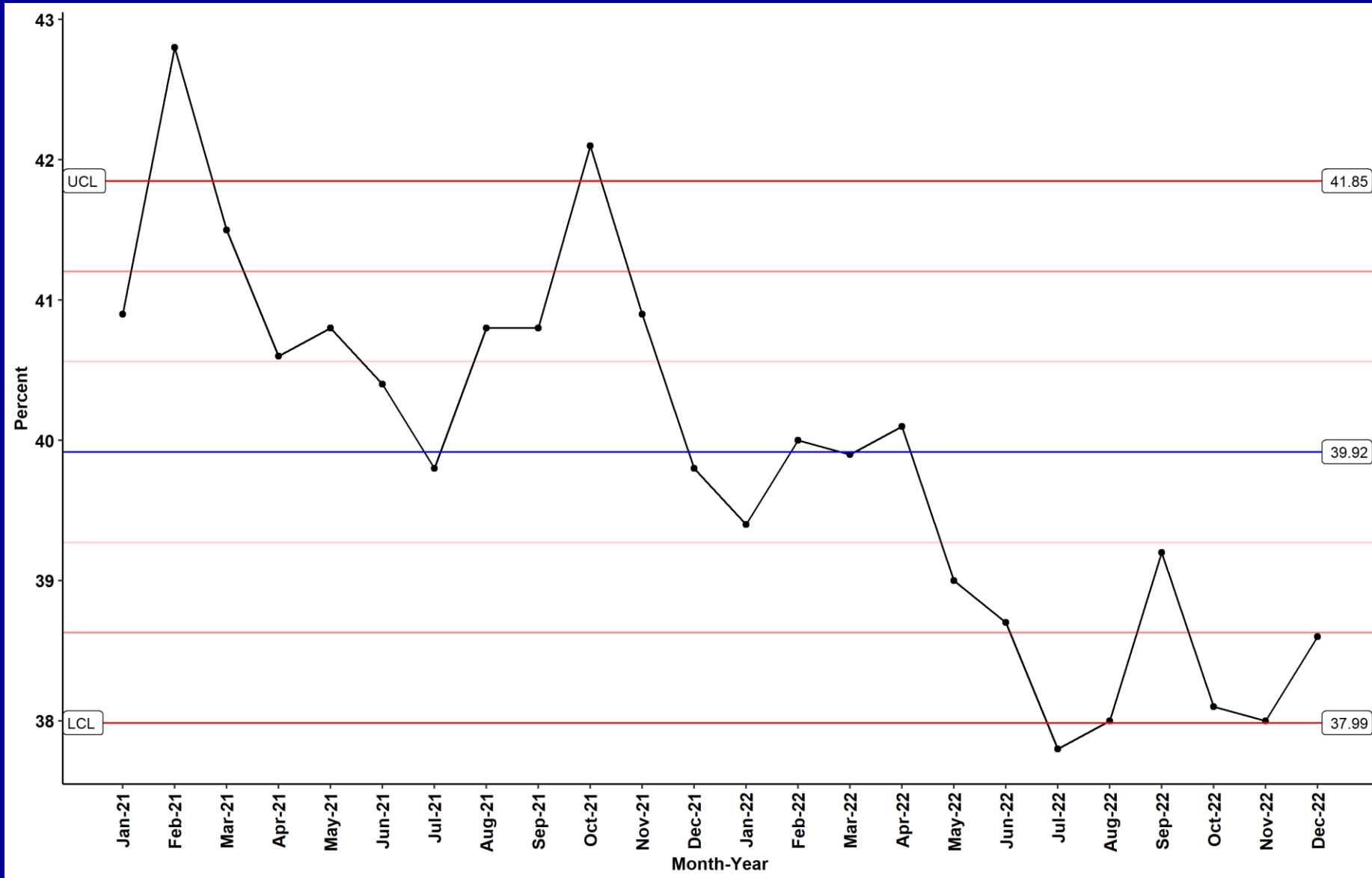
TRA- 2: Direct transport to trauma center for trauma patients



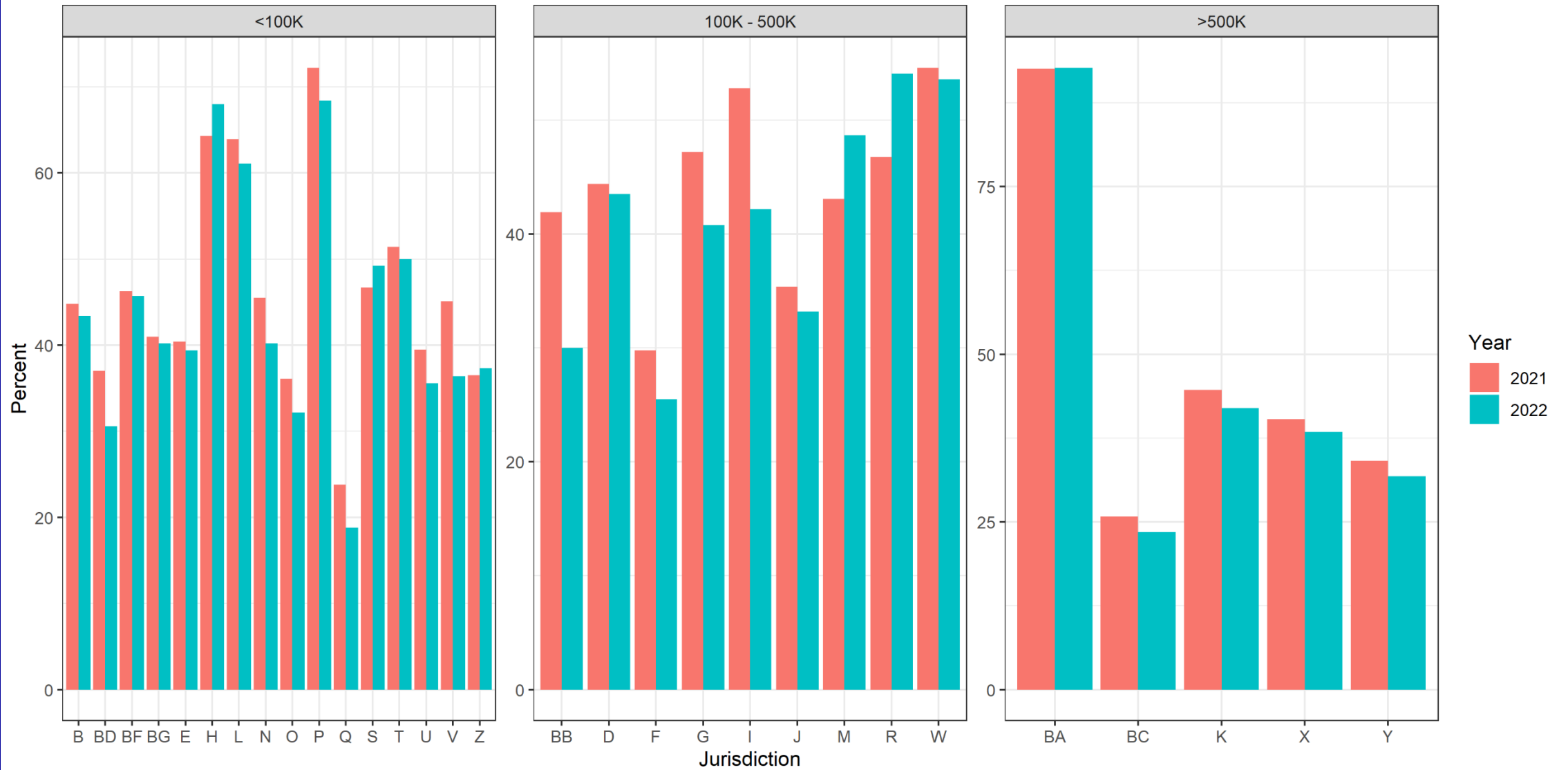

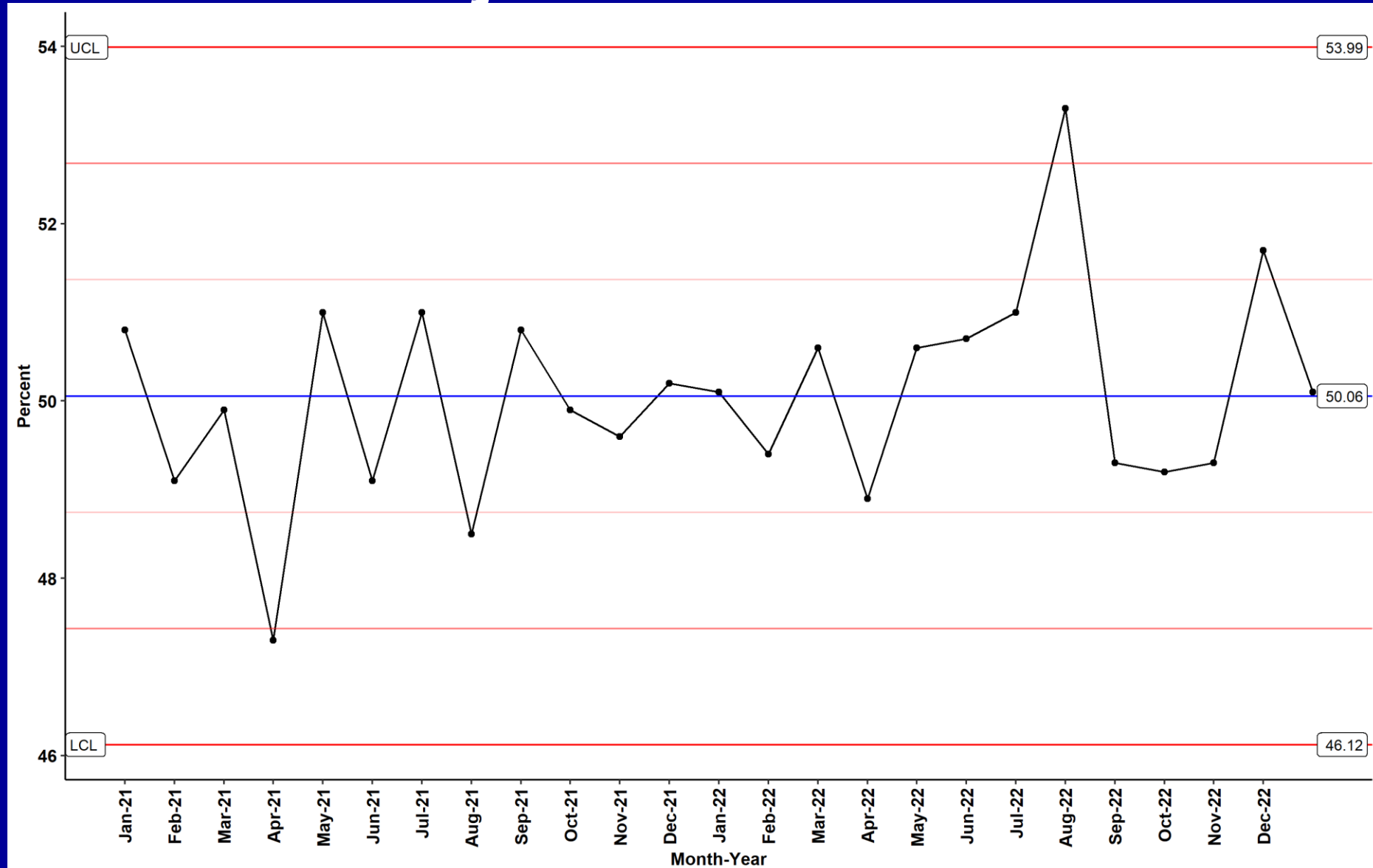

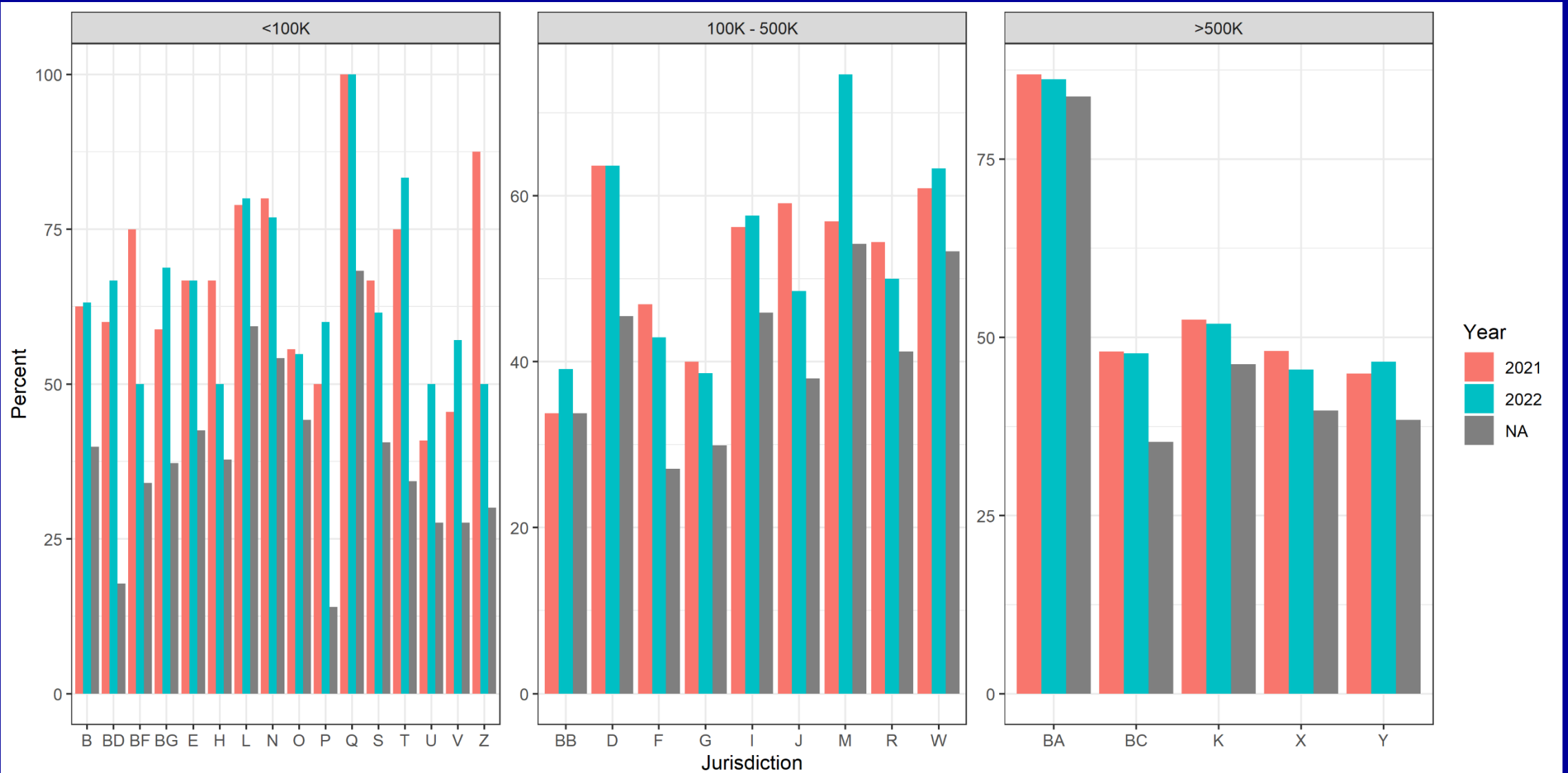

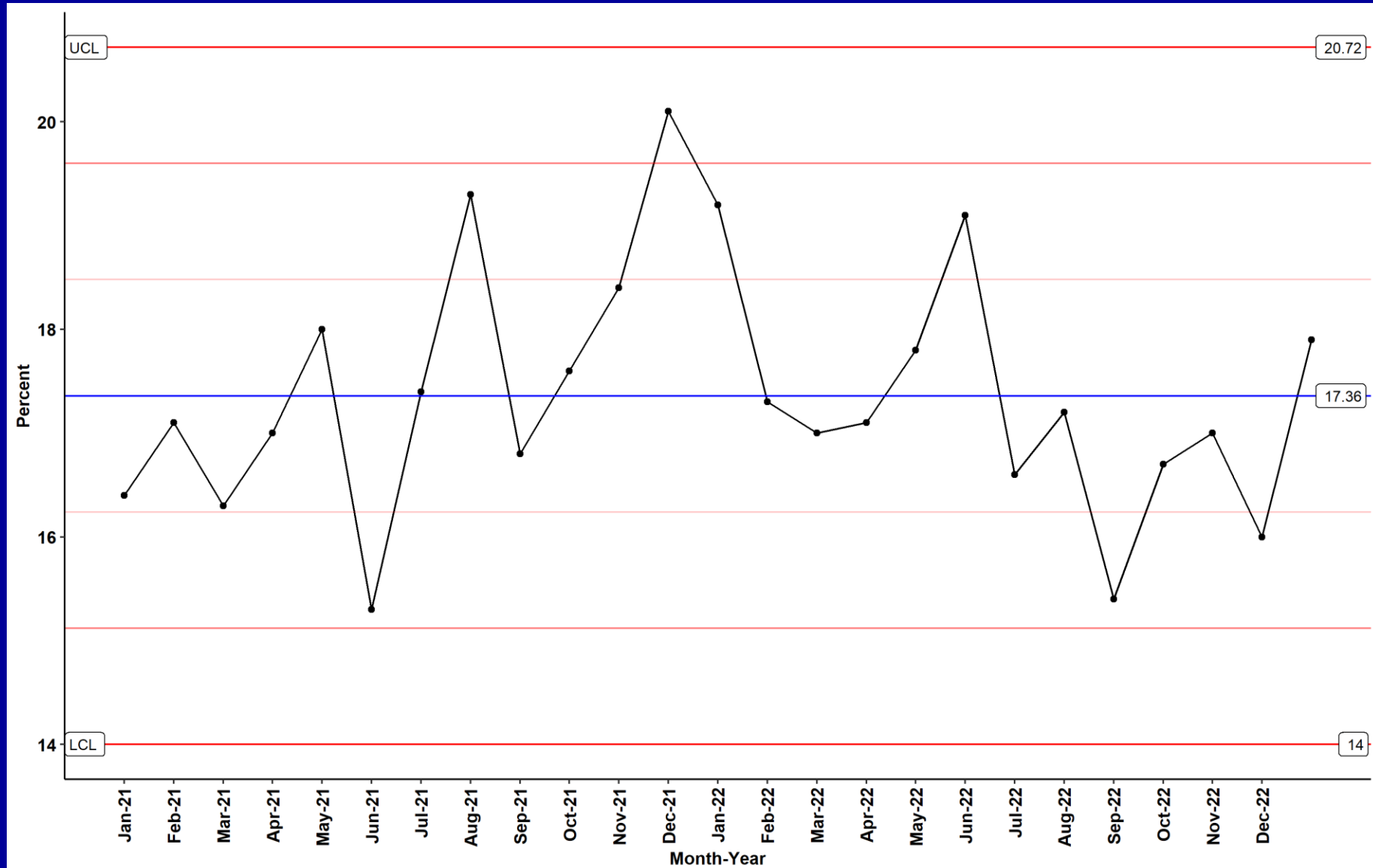

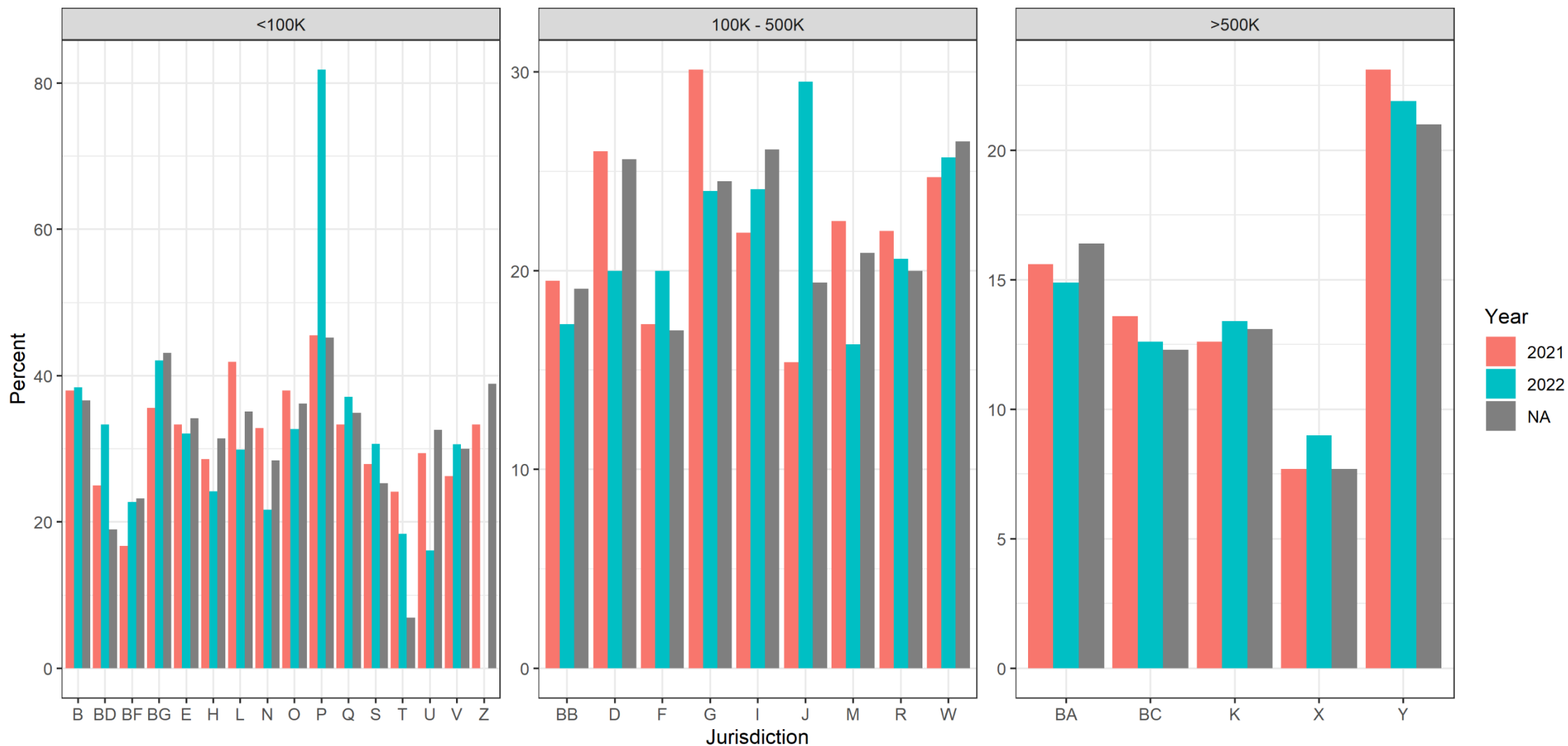


TRA- 5 : Measurement of patients with a decrease in their pain scale compared to initial pain scale

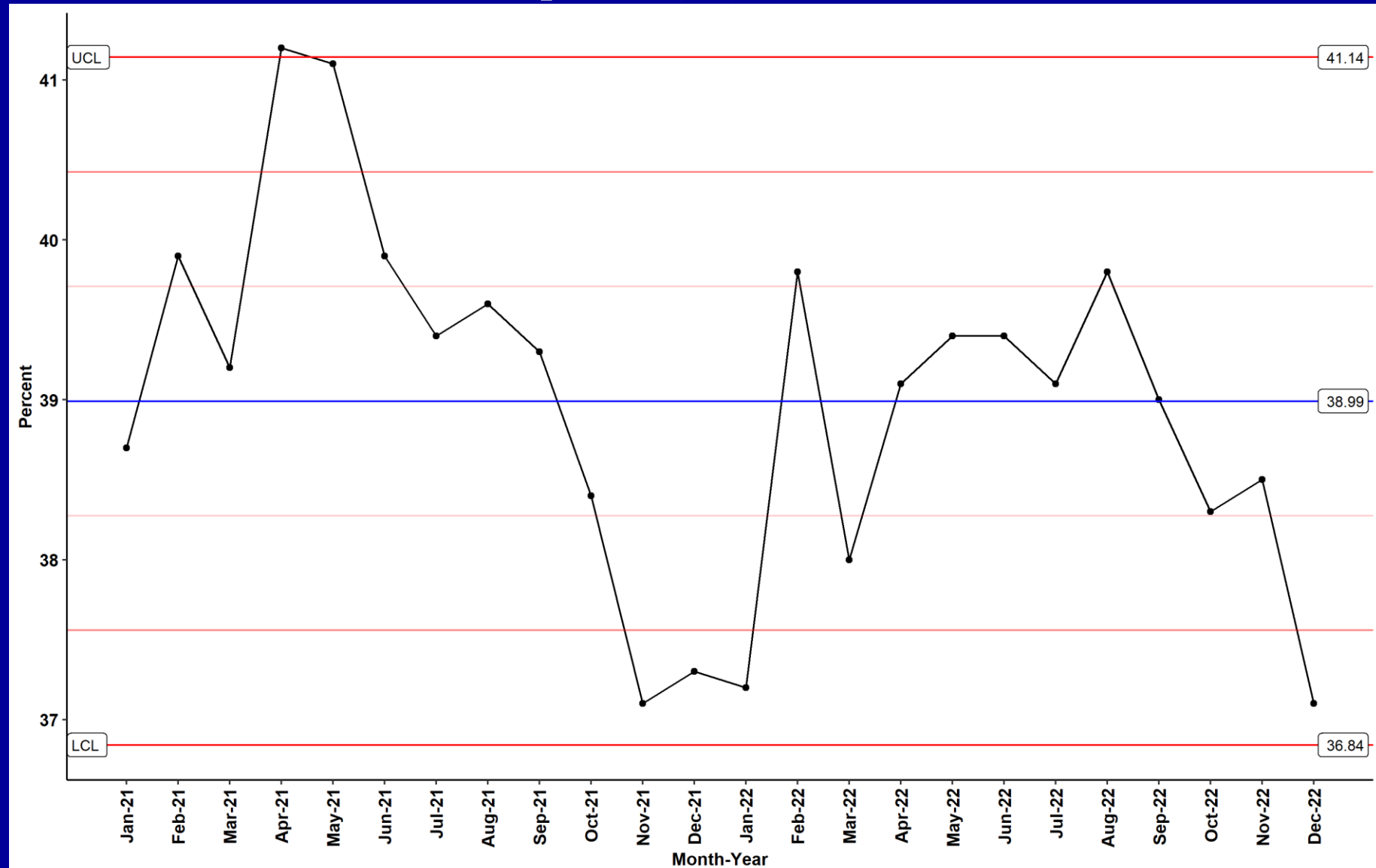

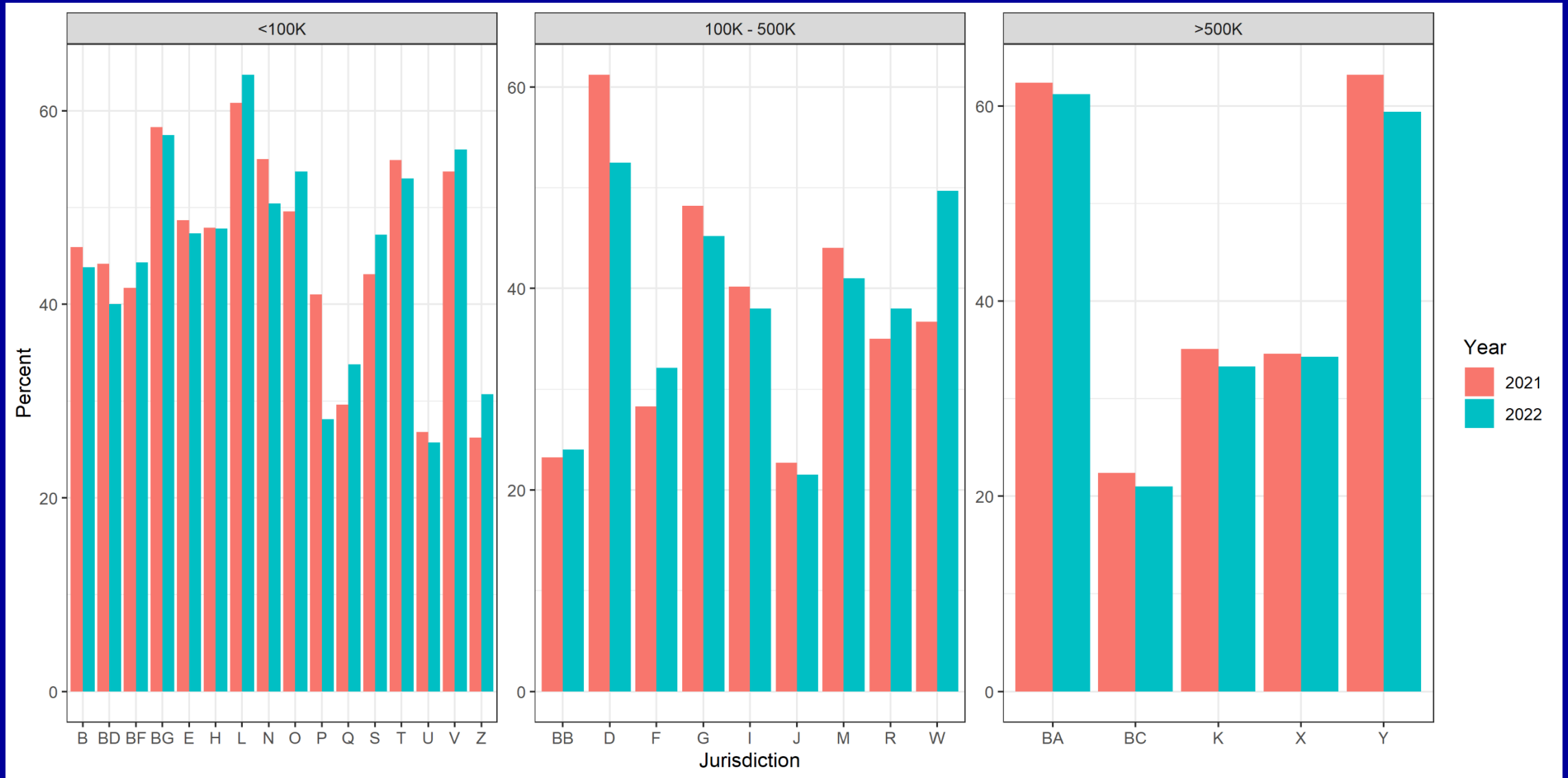
Percent of patients who received 2 or more pain scale assessments



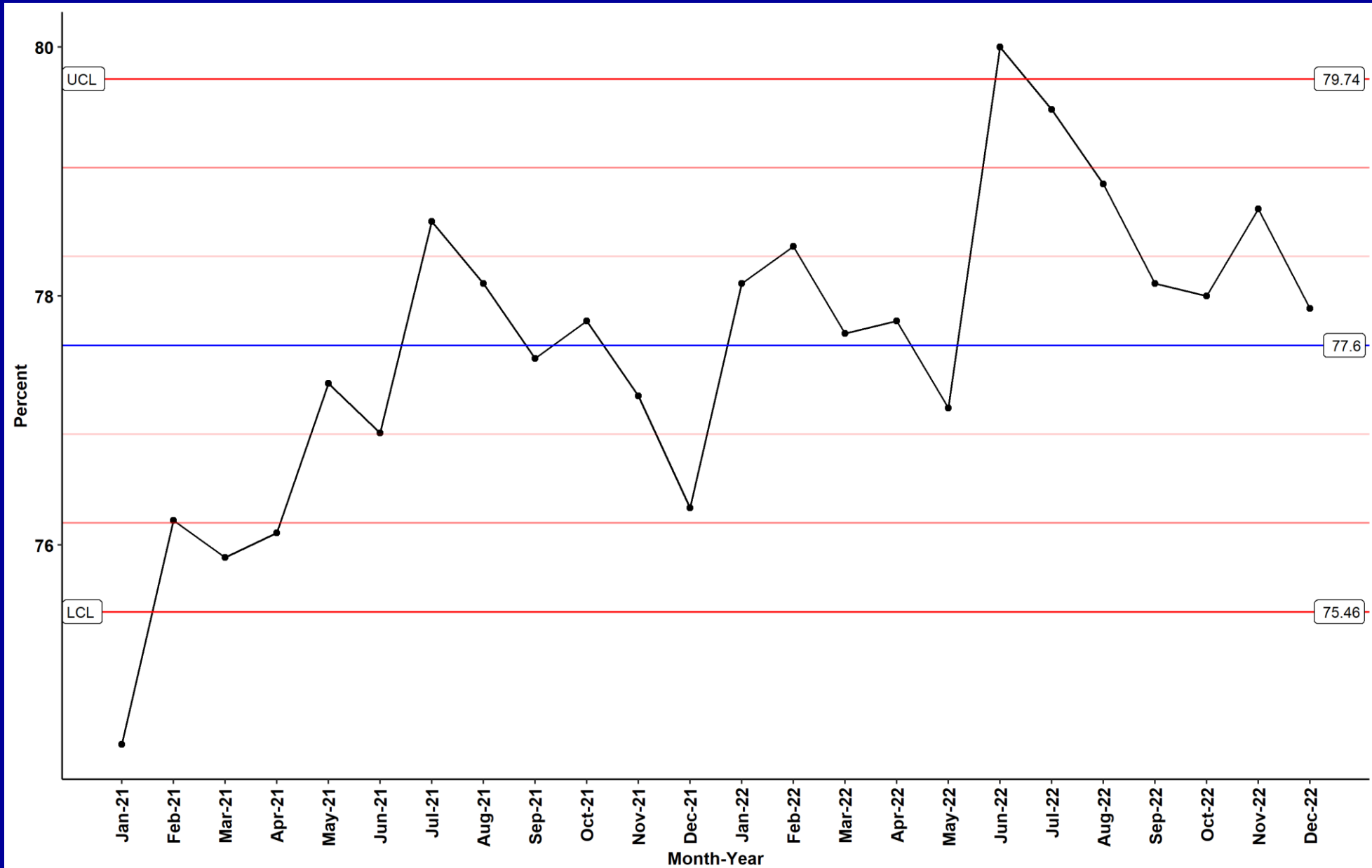

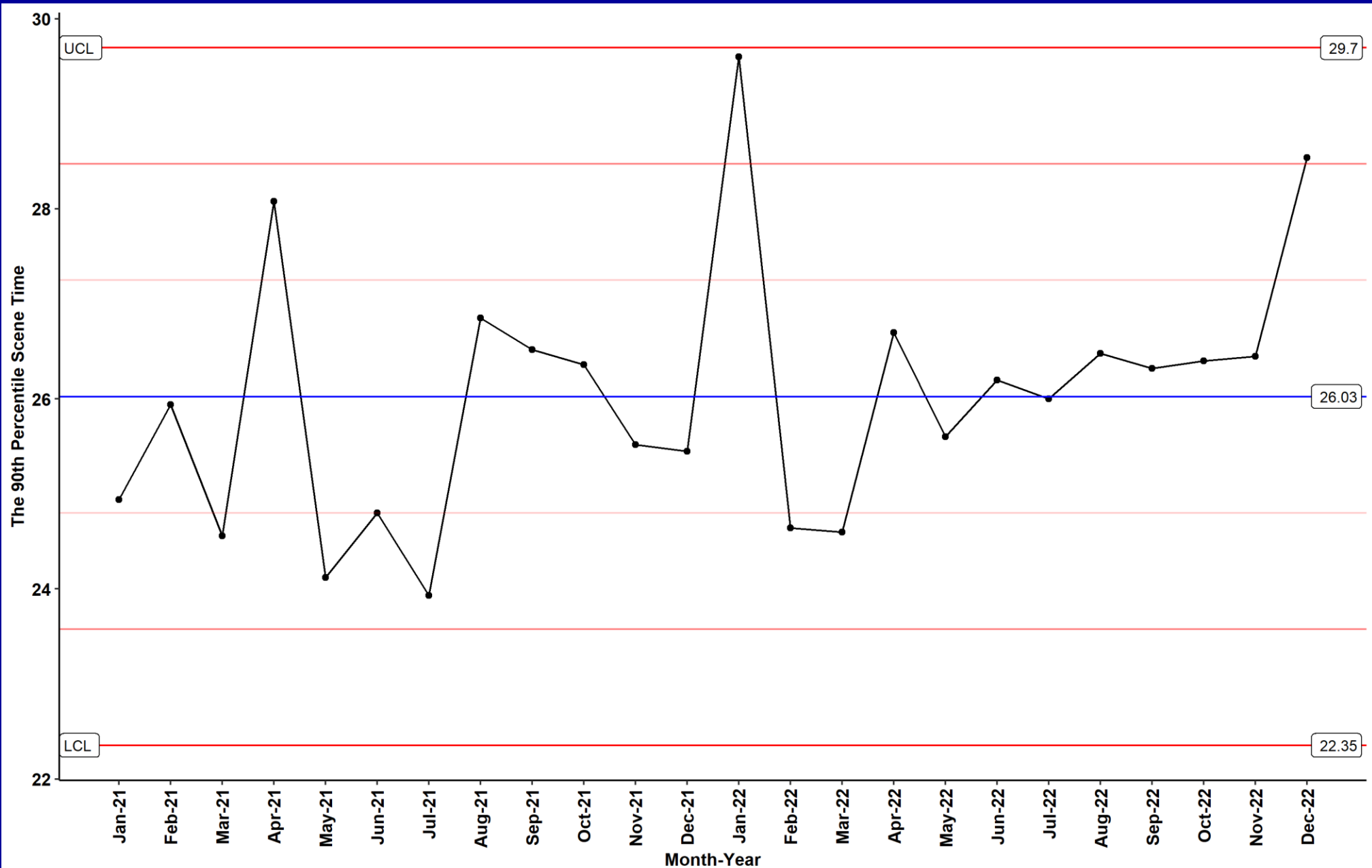

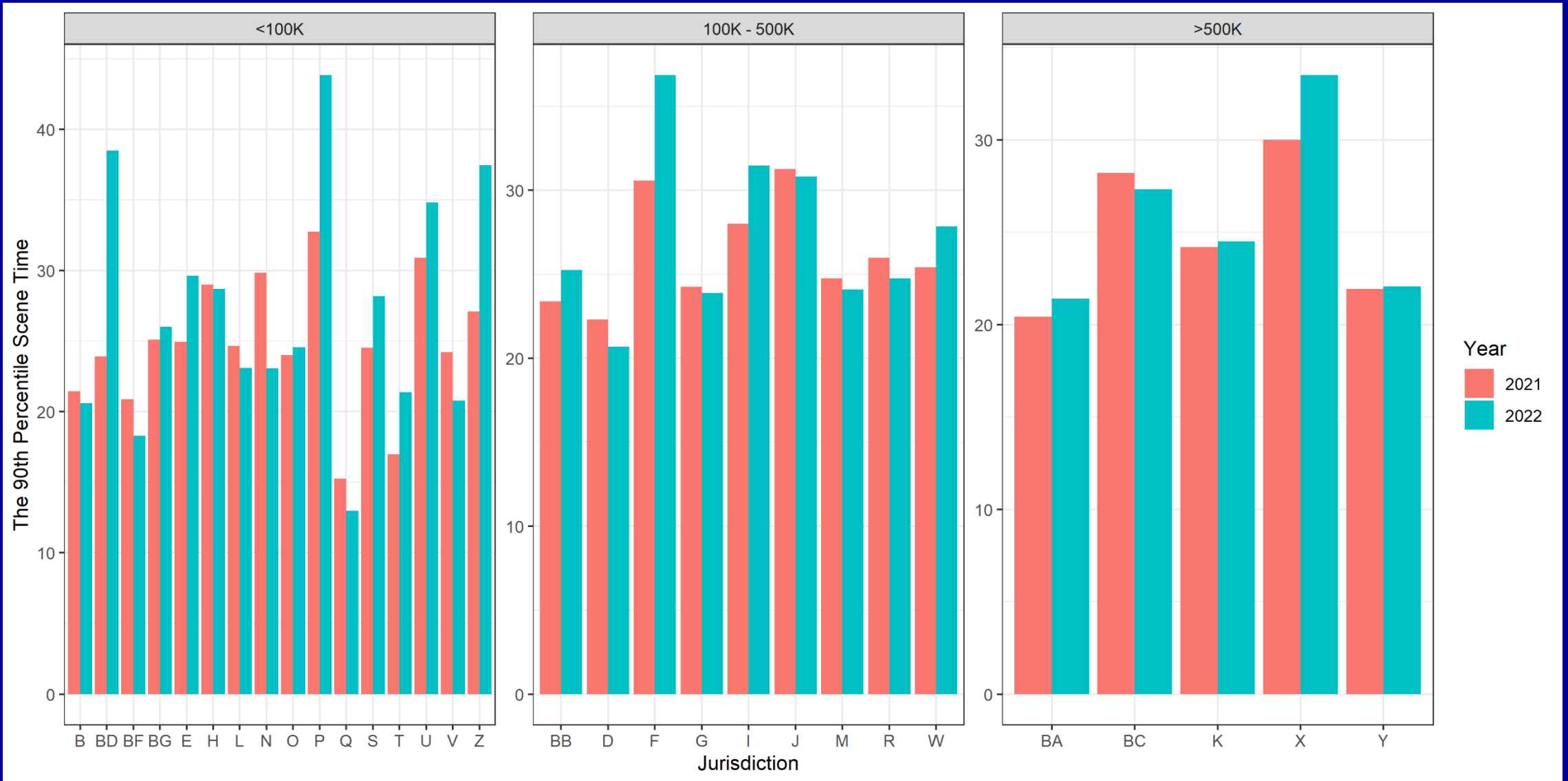

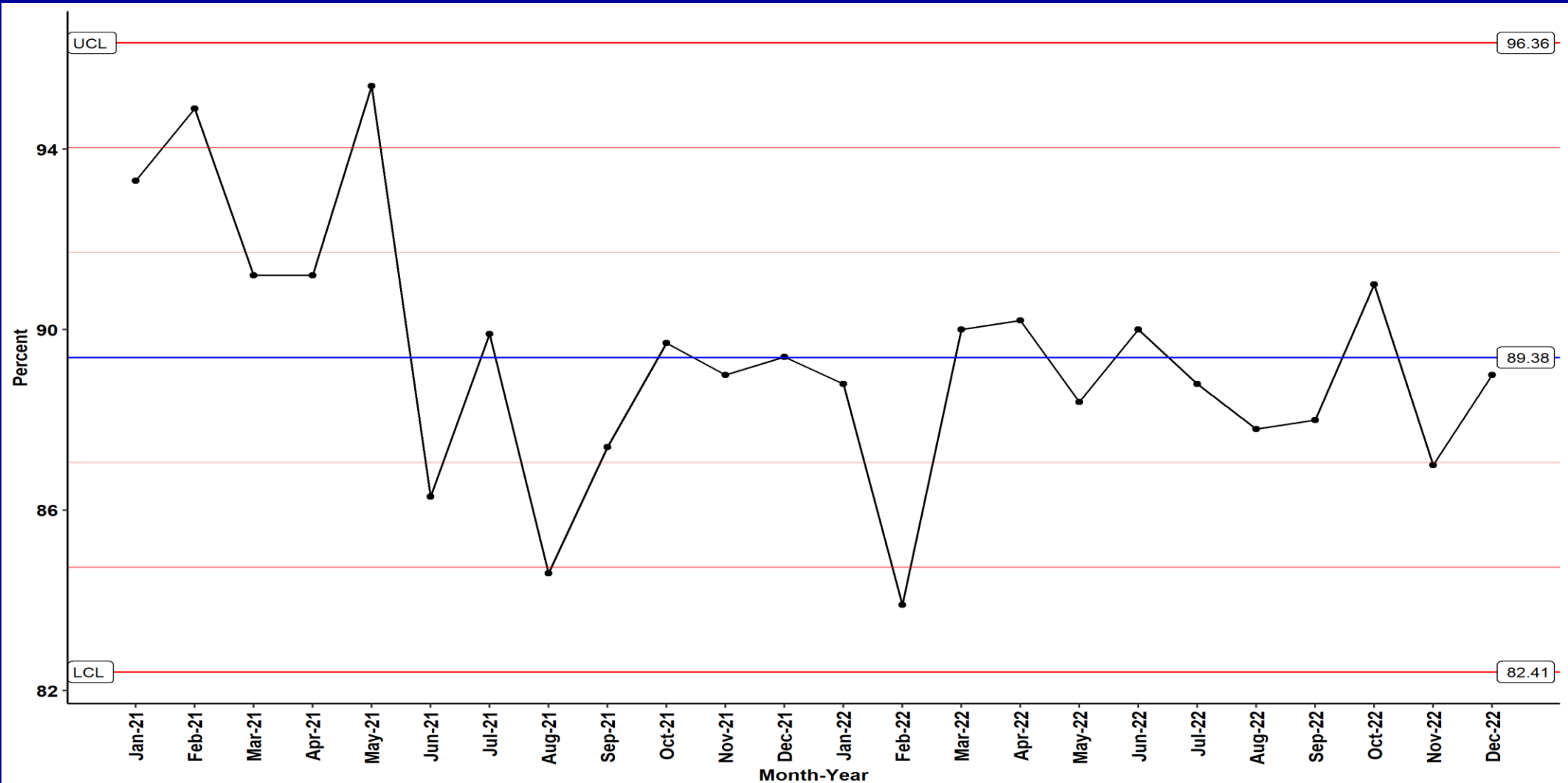

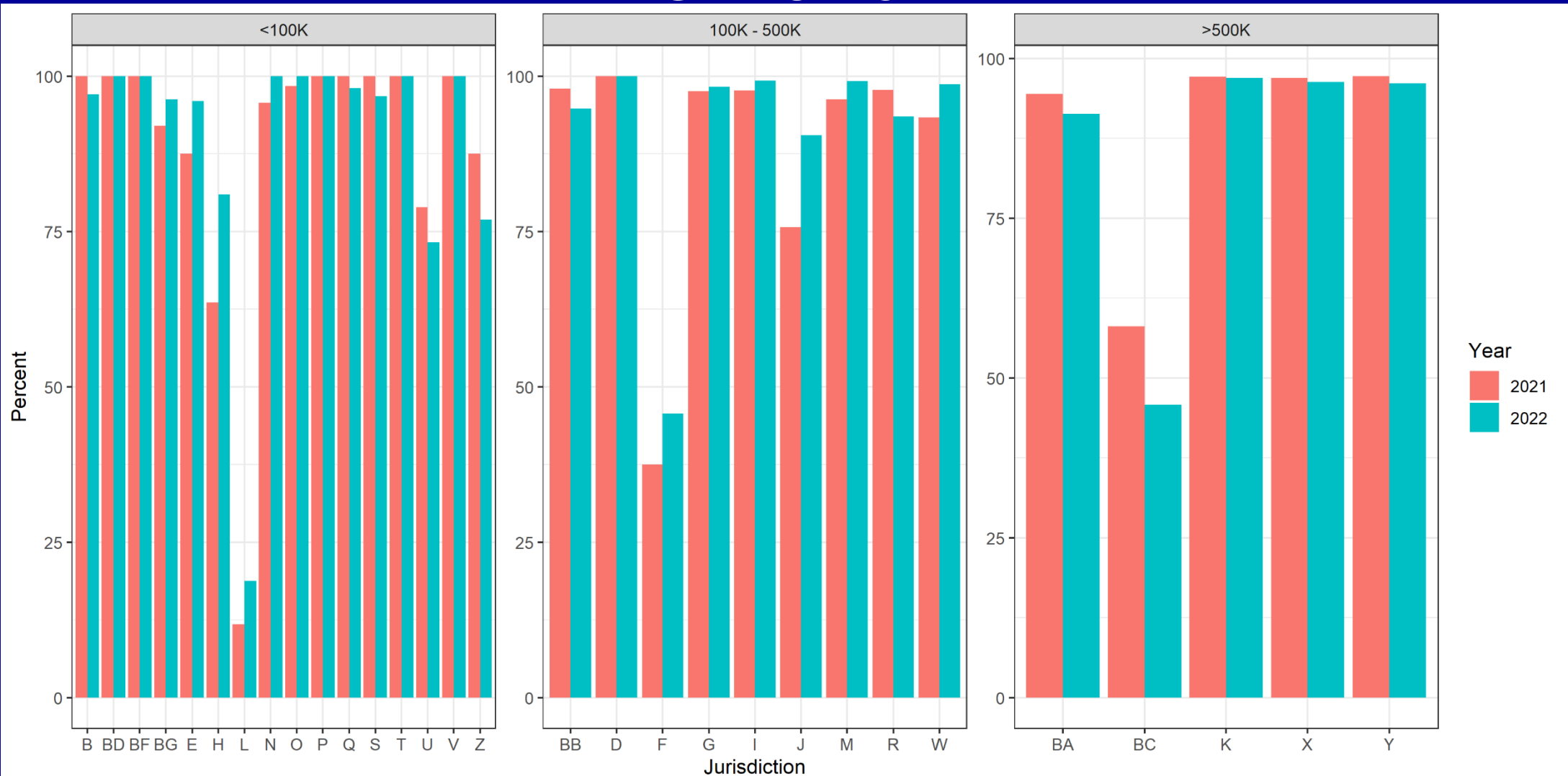

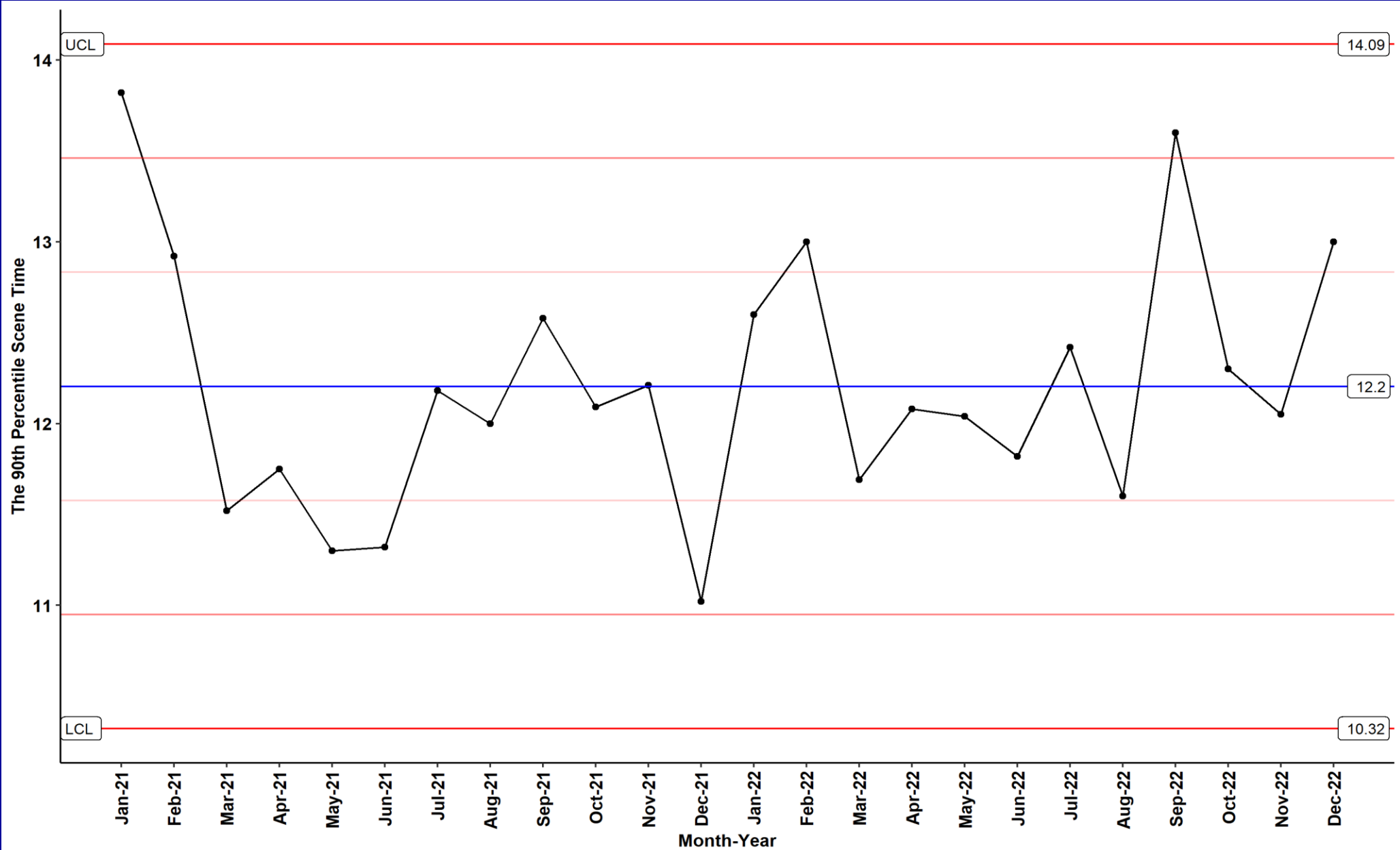

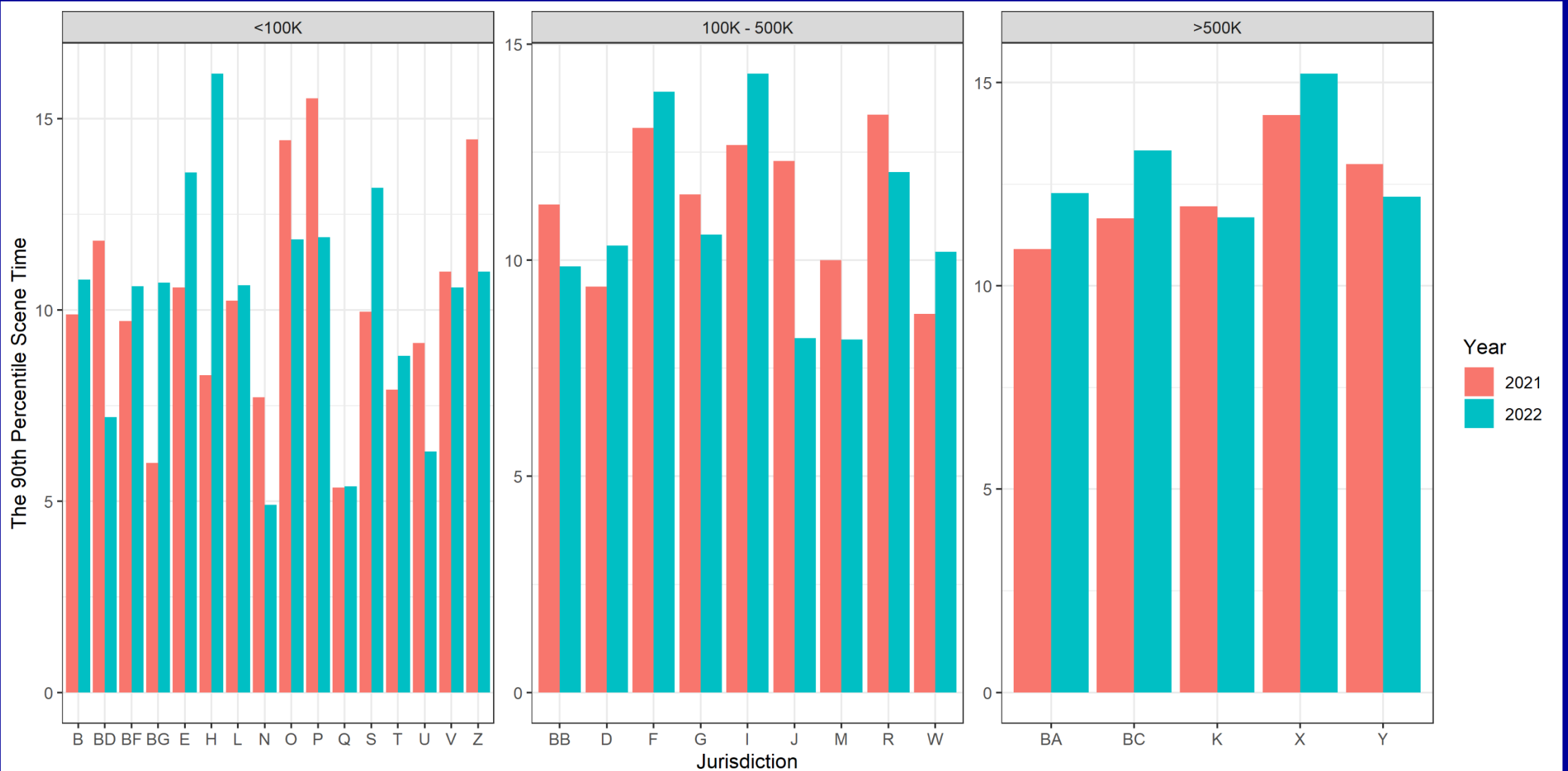

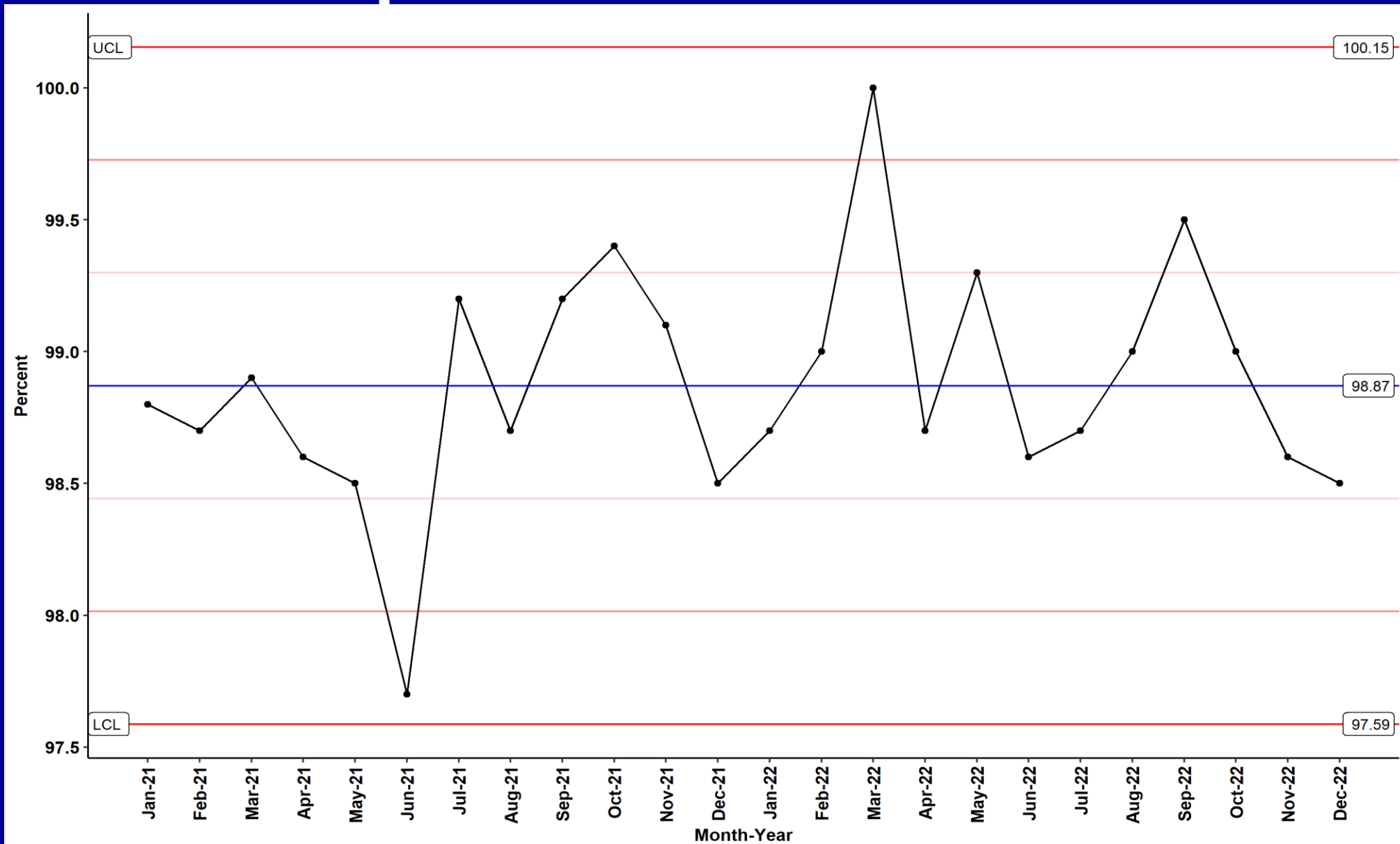

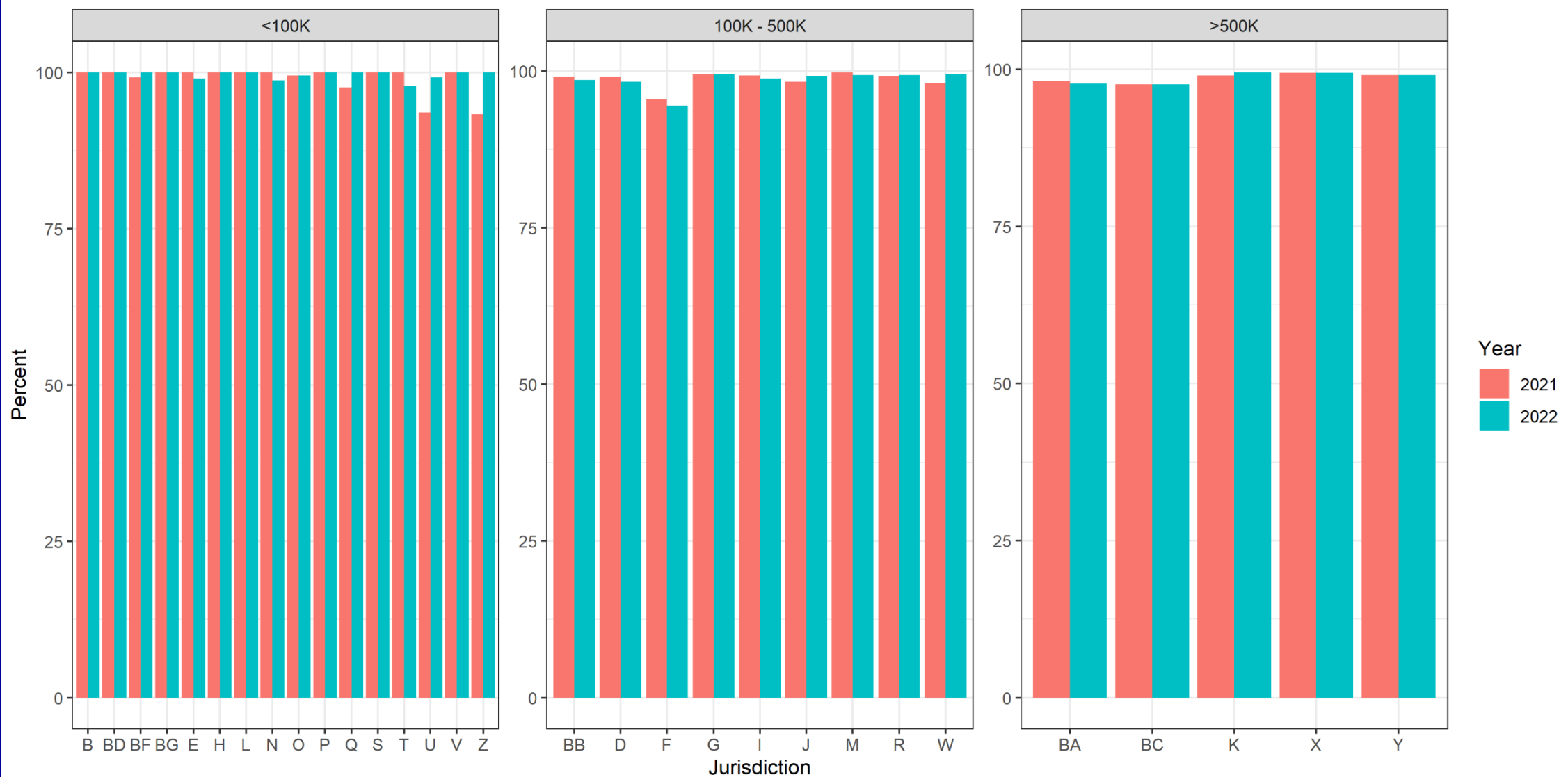

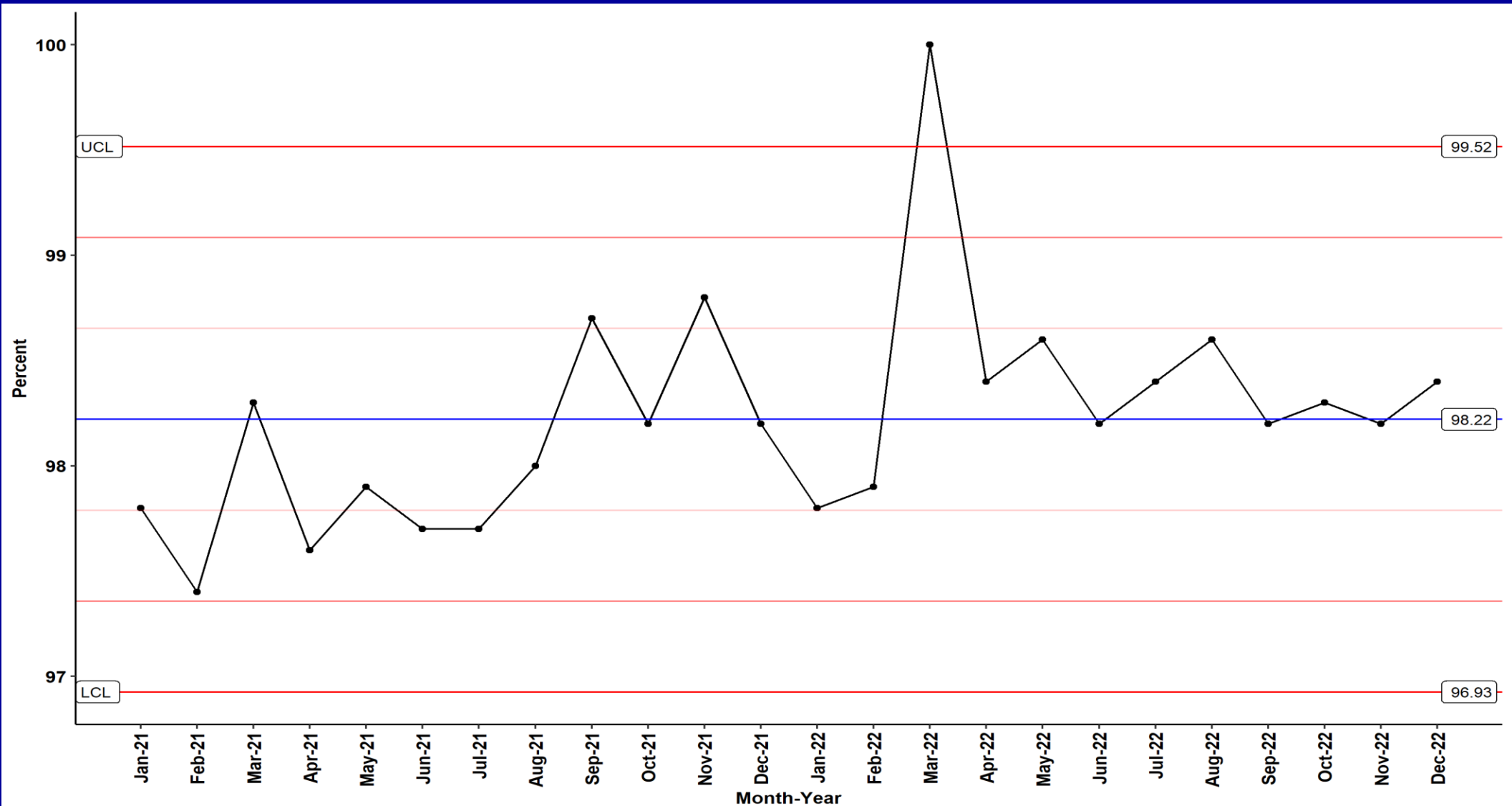

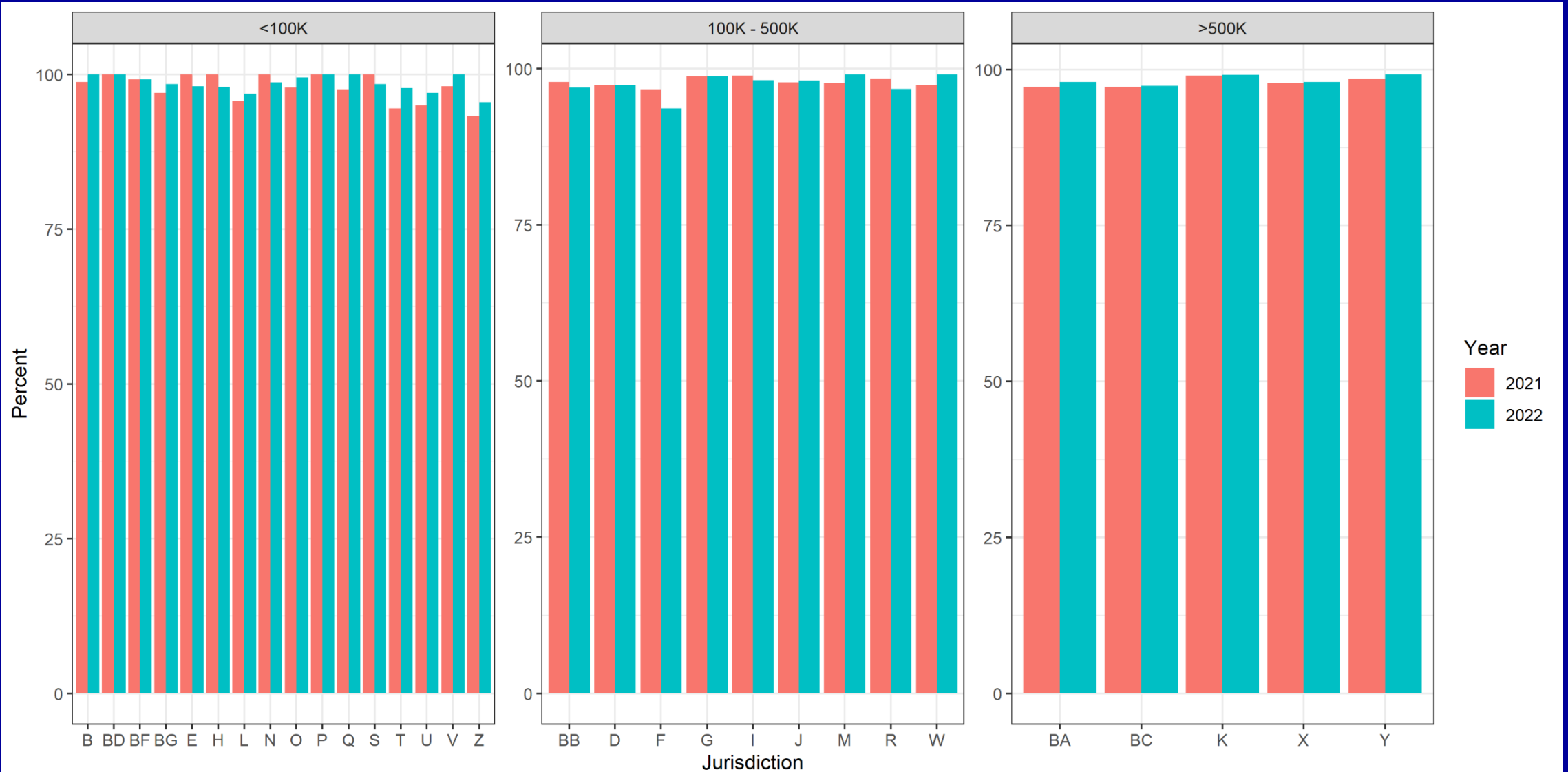

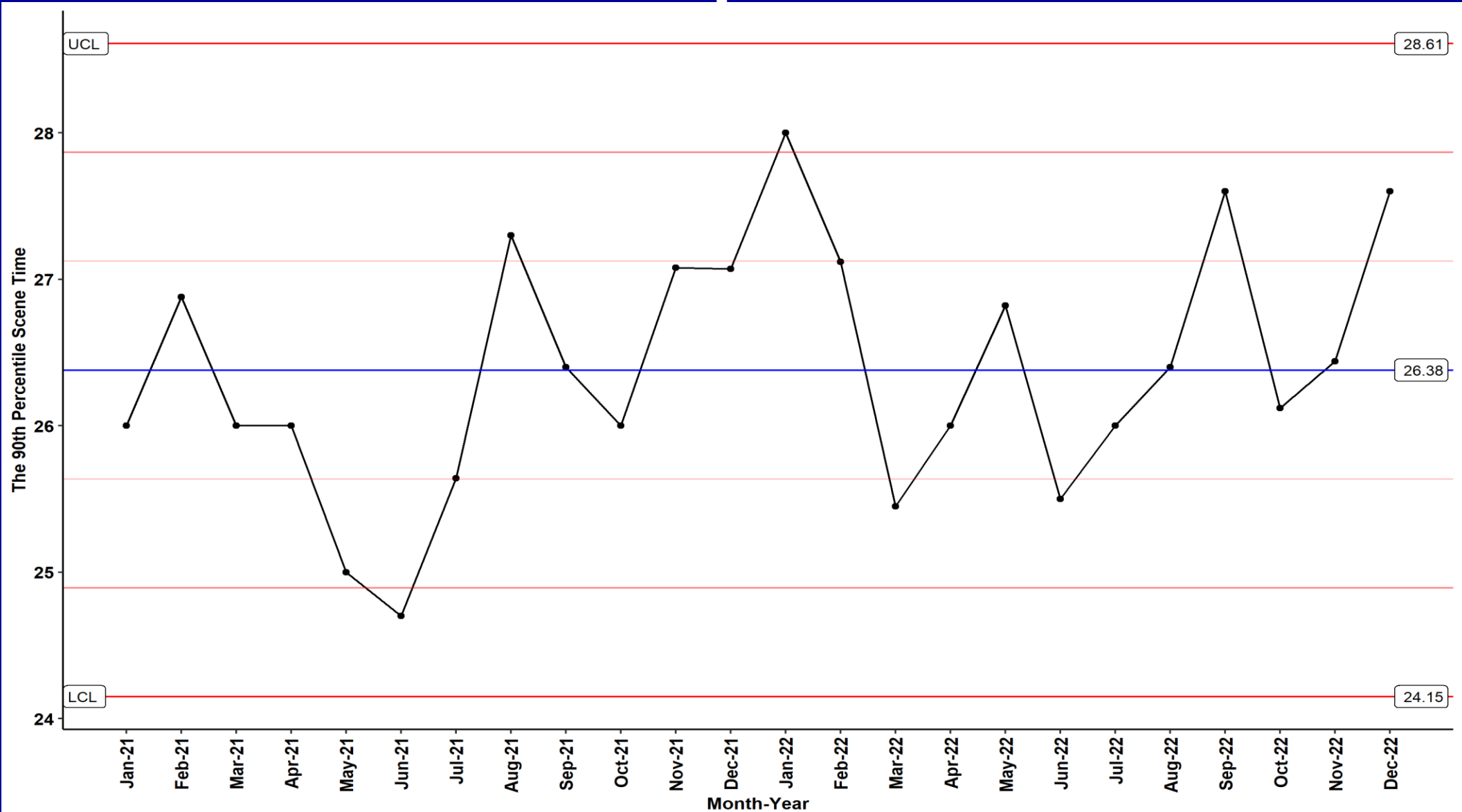

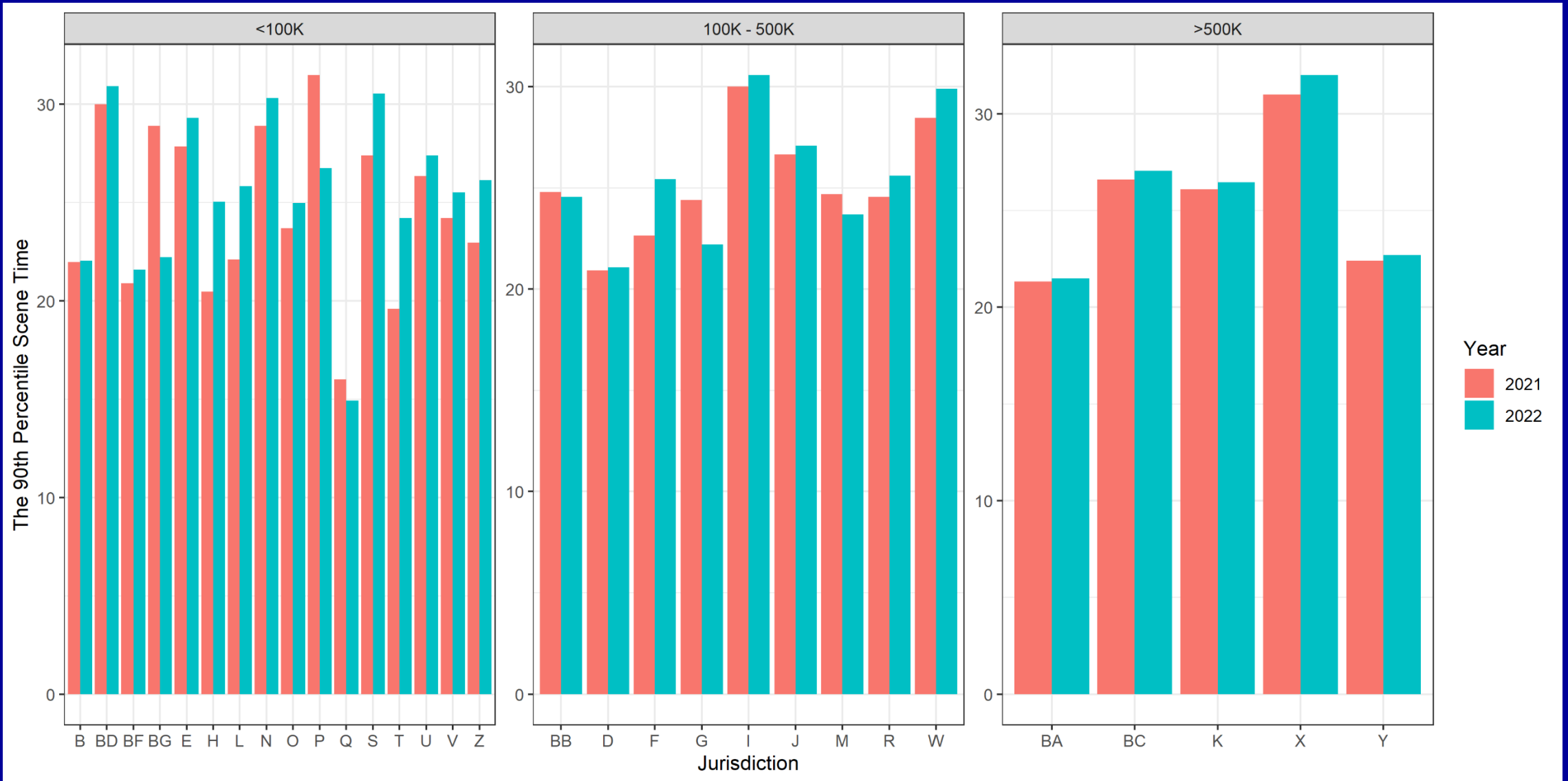

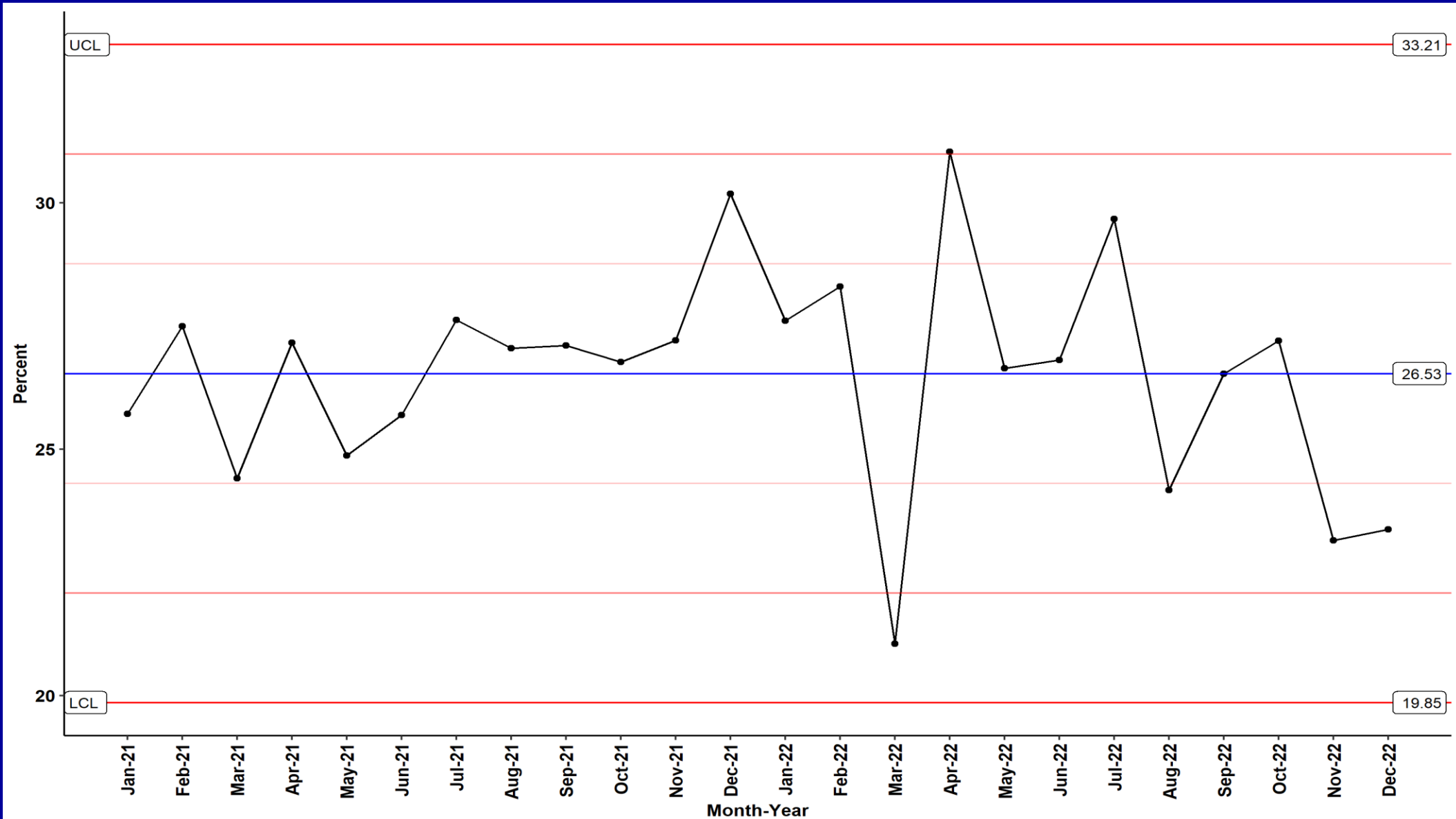

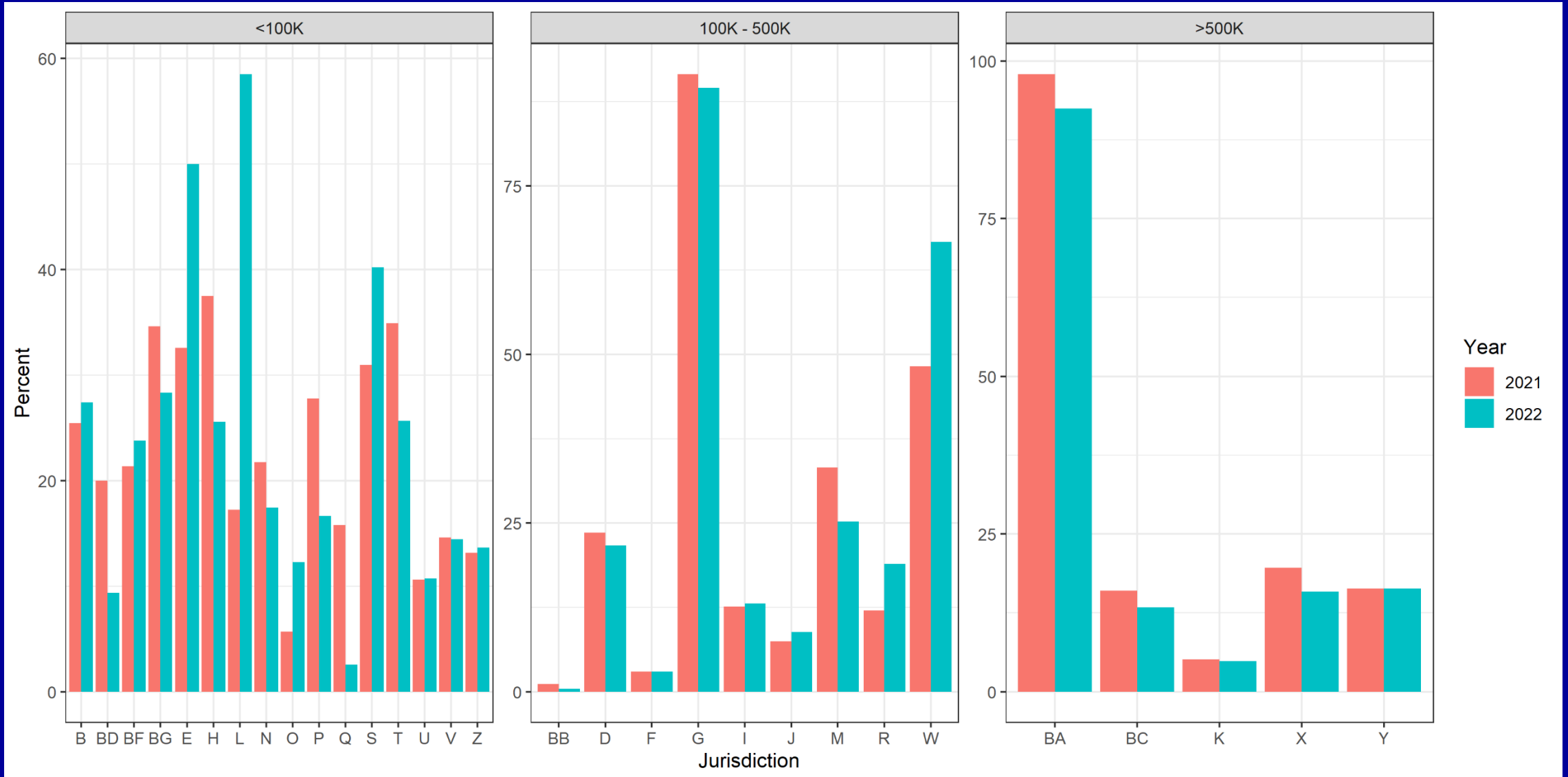

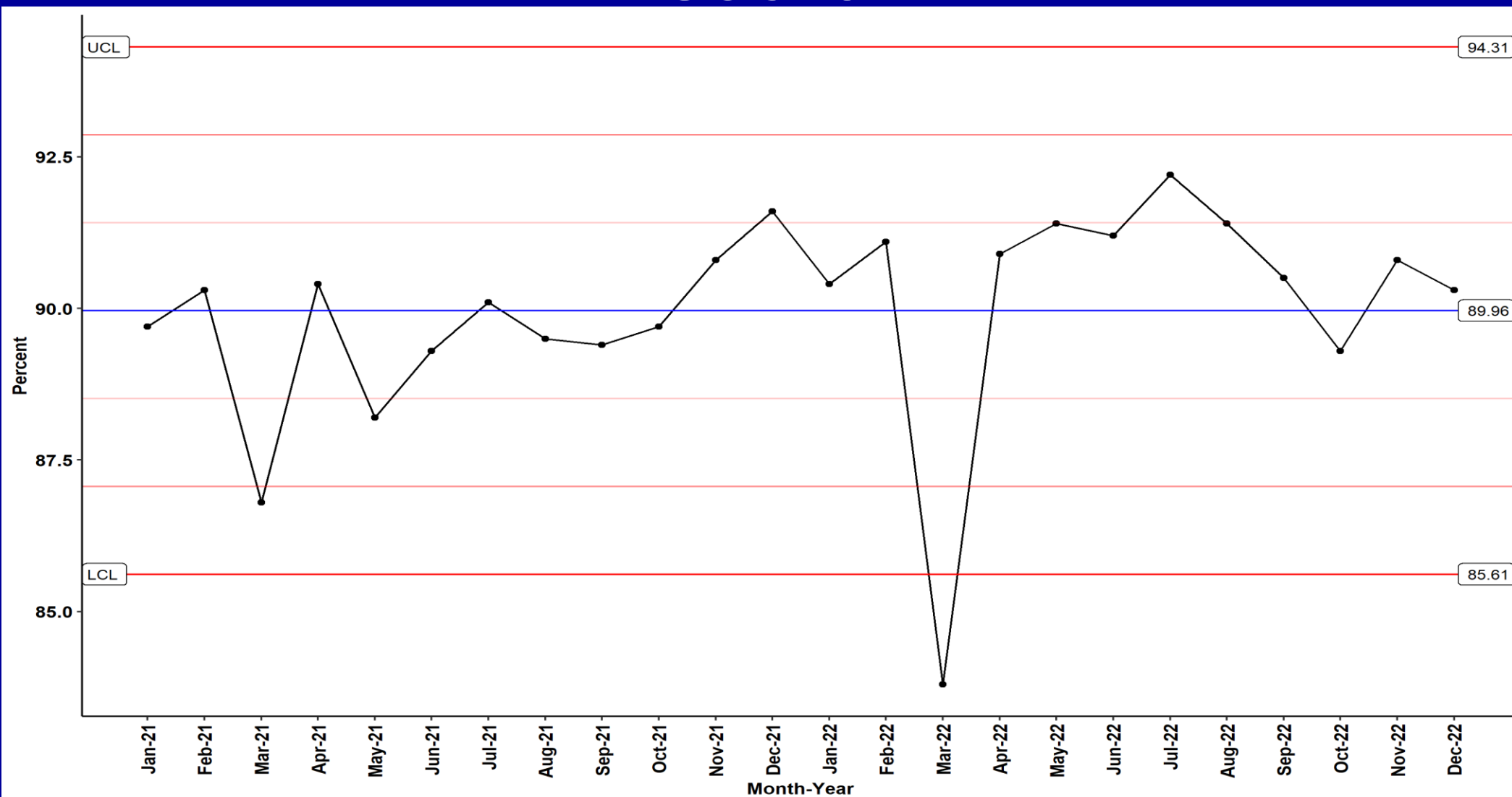

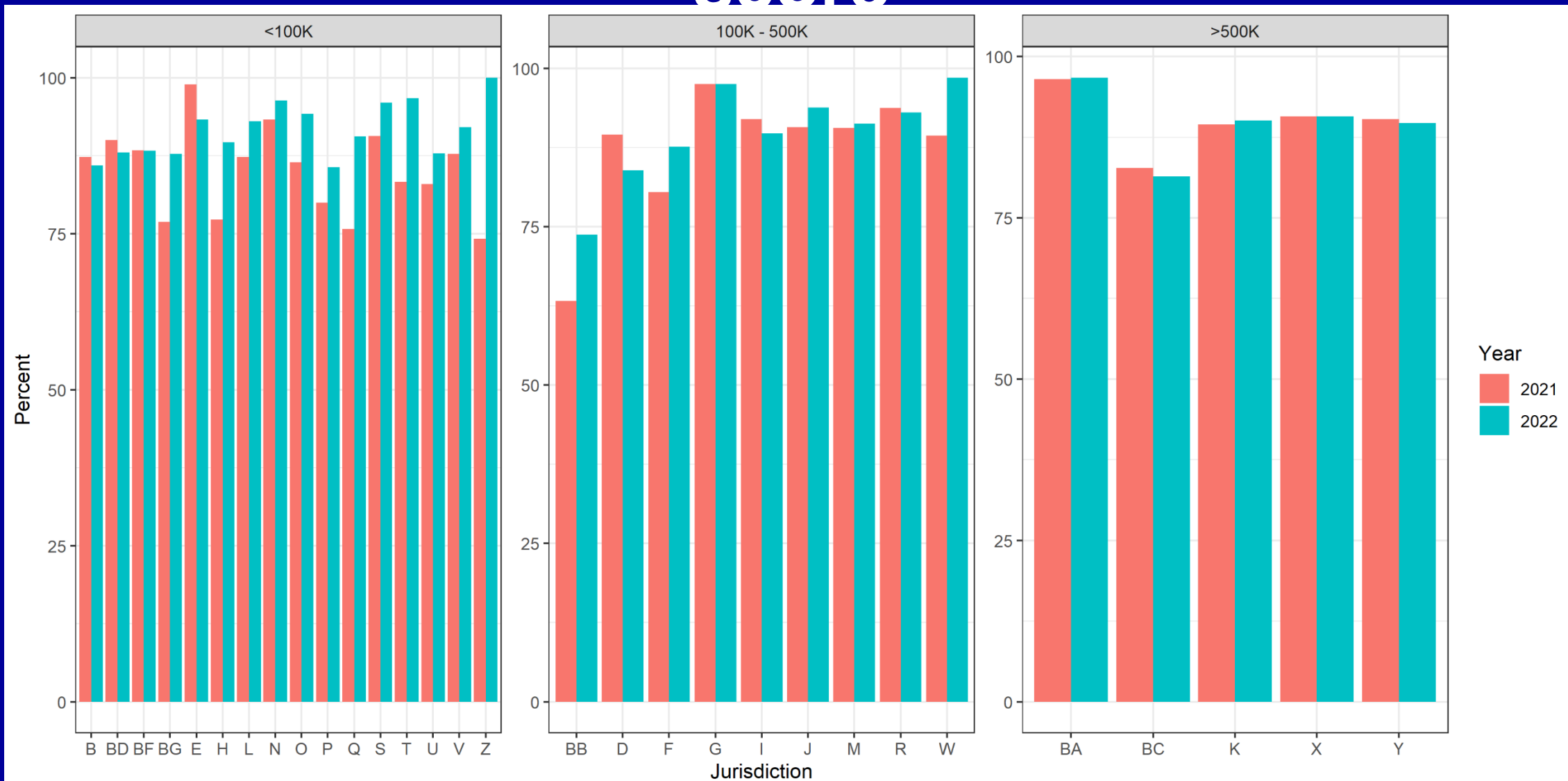

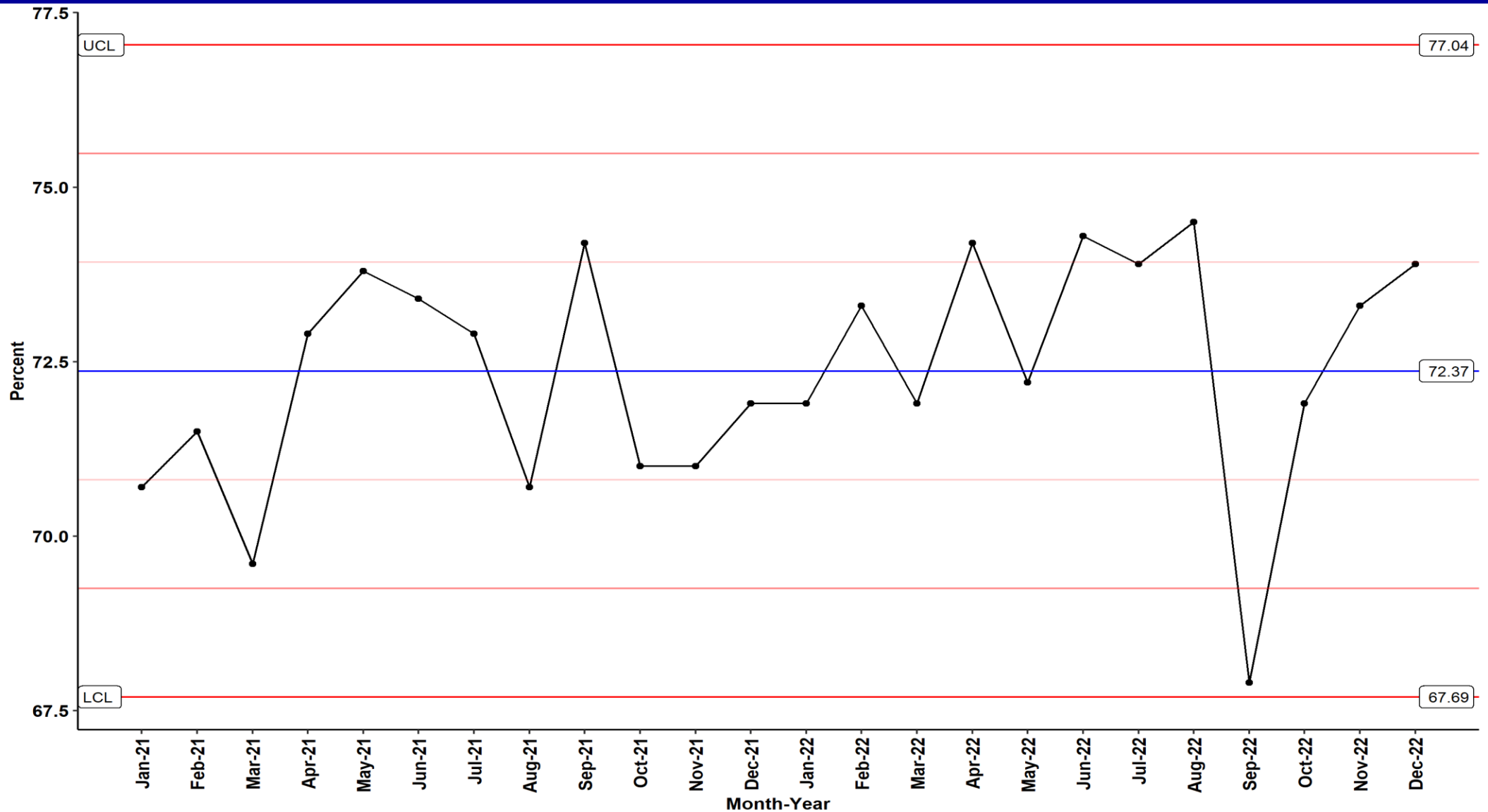
MD STR - 5 : Percent of patients with positive Cincinnati that also have documented LAMS score



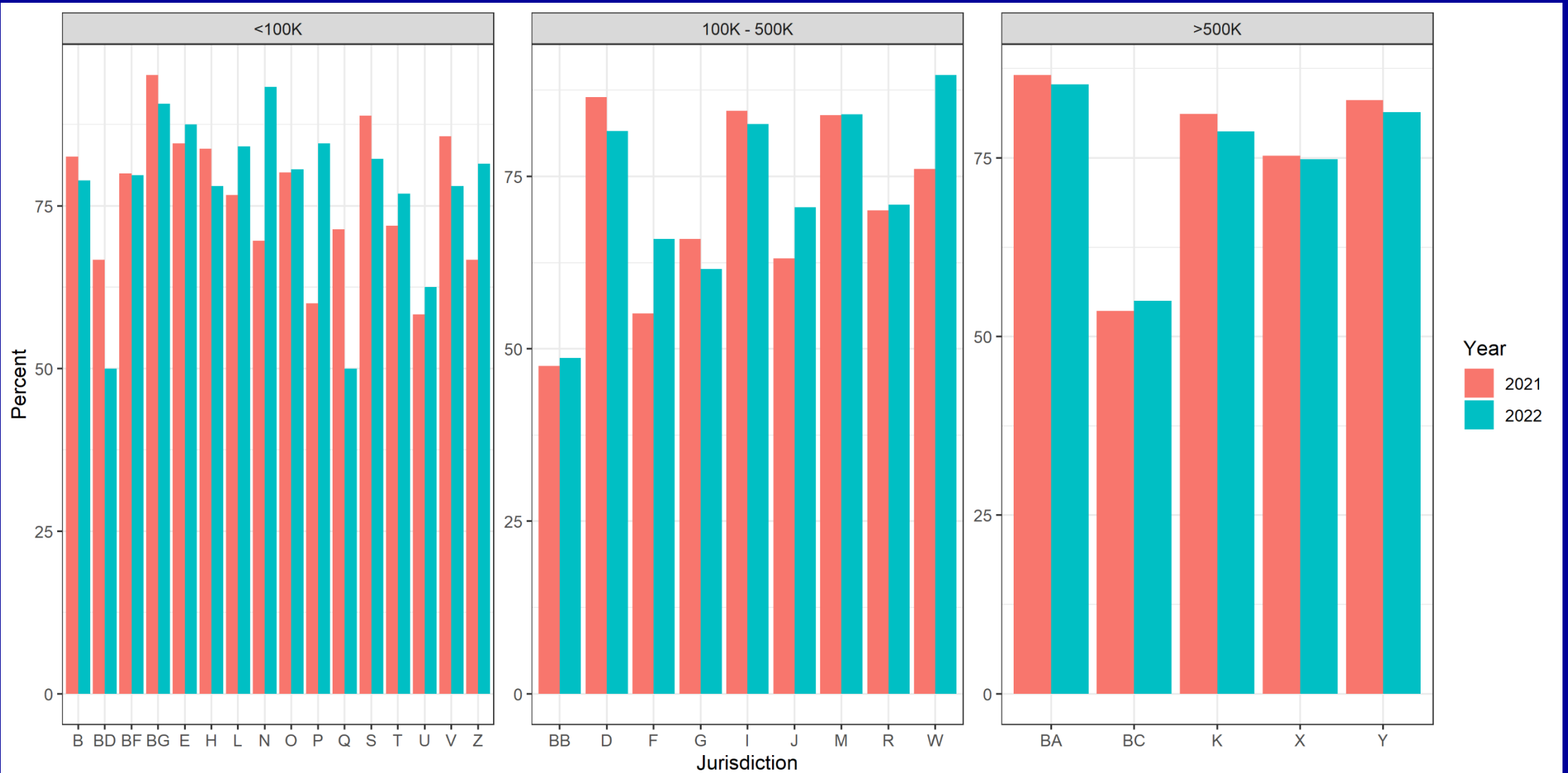

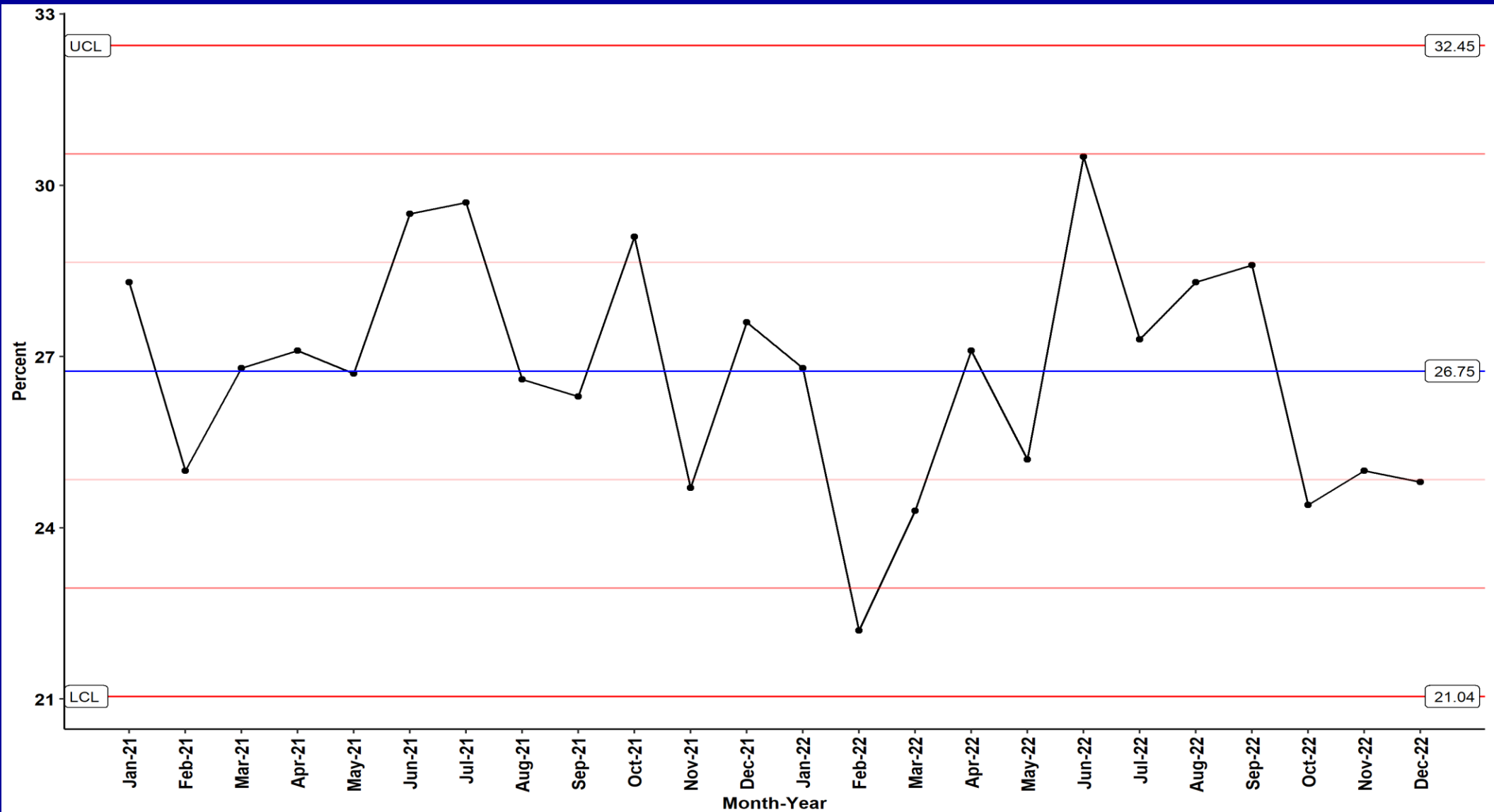
